To apply pupils must fulfil the following requirement at all times:

- A resident of Kent, whose parent/carer pays Council Tax to a Kent district council for KCC services
- In academic year 7-11* at a school or other recognised institution.

*Children who by age would ordinarily be in year 11 but have been put forward into year 12 are also eligible

Depending upon circumstances, you will be eligible to apply at one of the following fees:

- Full Year Pass (Valid from the start of the academic year until 31 July 2019)..... £290*
- First Half Year Pass (Valid from the start of the academic term until 1 March 2019)..... £145*
- Second Half Year Pass (Valid from 25 February 2019 until 31 July 2019)..... £145*
- For applicants qualifying for free school meals the fees are £100 for a full year and £50 for a half year
- For households applying for more than two passes the third and fourth pass is free
- Some applicants in Council Care categories are exempt from any fee.

New applications

The YPTP will be sent to school for collection by the named pupil.

Renewals

Renewed passes will be sent to the school and will be exchanged for expired passes. You do not need to include another photograph.

Please note KCC no longer issue letters to permit travel on the first day of term. Bus operators have agreed to allow children to travel for free for the first few days of school to allow for new passes to be collected, however, if possible please retain and present the expired pass during this period. You will receive written confirmation that your application has been processed.

Applications take up to 28 working days to process. In order to be ready for the first day of term, applications will need to be received by 13 July 2018 (for the full and first half year pass) and by 4 January 2019 (for the second half year pass).

New Year 7 pupils will not be issued with a YPTP until the pupil is attending secondary school.

Kent County Council will not be liable for any costs associated with submitting an application or for any expense incurred whilst awaiting receipt of your pass. If you applied by the deadline and the YPTP is not available for collection during the first week of term or if you applied after the deadline but have not received the YPTP within 28 working days, please contact us.

Lost, stolen or damaged passes

Where the pass has been lost, stolen or damaged, a replacement pass will be issued subject to the current replacement fee, which is £10. Should the replacement pass be lost, stolen or damaged, two further replacements per school year will be issued upon payment of the replacement fee. Thereafter you may make a new application at our discretion and the appropriate application fee will apply.

Payment

Please enclose a cheque or postal order payable to Kent County Council for the appropriate application fee. Please do not send cash by post. The application fee will not be waived under any circumstances and applies irrespective of the date of application. Application fee refunds will not be processed once the pass has been collected and used.

The information you provide on this form is collected and dealt with in compliance with the General Data Protection Regulation. We are relying on the lawful bases of public task and that the individual has given clear consent for us to process their personal data for a specific purpose. The purpose of the processing is to facilitate your access to the concessionary travel scheme. It will be used by Kent County Council to administer, arrange and manage the transport or scheme for which you are applying. It may be shared third parties (such as transport providers or travel card manufacturers) only for the purposes of enabling individuals to access the schemes. Data may be subject to automatic processing and will be securely stored for the period of the benefit for travel plus 1 year. Kent County Council Public Transport is the data controller and the data protection officer is dpo@kent.gov.uk. You have various rights in relation to the data and how it is processed and the right to lodge a complaint with the ICO. If you do not provide the required data, we will be unable to provide a service to you.
