## ADMISSION ARRANGEMENTS

The Governing Body is the admissions authority for the Whitstable & Seasalter Endowed Church of England (Aided) Junior School. The Governors are planning to admit (Published Admission Number) 48 children to Year 3 in September 2017. The School has an Admission Number of 48 for Years 4, 5 and 6. Children will be admitted without reference to ability or aptitude. Before the application of oversubscription criteria children with a statement of special educational need or education, health and care plan which names the school will be admitted, in which event the Published Admission Number will be reduced accordingly.

Even if you do not meet any of our criteria (a) to (f) listed below, you are entitled to name the Endowed School as a preference and due consideration will be given to your application by the Governing Body. If applications exceed the number of places available the oversubscription criteria will be applied in the following order of priority which will also be used if applications within any of the categories exceed places available and it is necessary to decide between them:

- a) **Looked after and Previously Looked After Children of Church Faith** – A child for whom the Local Authority provides accommodation by agreement with his or her parent/carer (Section 22 of the Children Act 1989) or who is subject of a care order under Part IV of the Act or who ceased to be so looked after because he or she was adopted or became subject to a residence order or special guardianship order (as defined by Section 46 of the Adoption and Children Act 2002 or Section 8 or 14A of the Children Act 1989) and who has attended worship or Sunday school, or is in the care of a guardian or adoptive parent who has attended worship, at a Church which is part of Churches Together in England or the Evangelical Alliance or at Hamilton Road Evangelical Church at least twice a month for a continuous period of 12 months up to the date of application. Confirmation must be provided by the priest or minister at the church attended that the child, or guardian, has so attended at the church or previous church at least twice a month for a continuous period of 12 months up to the date of application.
- b) **Other Children of Church Faith** - A child living in the parish of the Whitstable Team Ministry (see attached map), who has attended worship or Sunday school at a church which is part of Churches Together in England or the Evangelical Alliance or at Hamilton Road Evangelical Church at least twice a month for a continuous period of 12 months up to the date of application. Confirmation must be provided by the priest or minister at the church attended that the child has so attended at the church or previous church at least twice a month for a continuous period of 12 months up to date of the application.
- c) **Other Looked After and Previously Looked After Children** – A child not of church faith as defined above for whom the Local Authority provides accommodation by agreement with his or her parent/carer (Section 22 of the Children Act 1989) or who is subject of a care order under Part IV of the Act or who ceased to be so looked after because he or she was adopted or became subject to a residence order or special guardianship order as defined above.





- d) **Children with a Current Family Association** - A brother or sister attending the Endowed School when the child starts or, after giving priority for such children, at the time at which application is made defined as a natural brothers and sisters, adopted brothers and sisters, step brothers and sisters, foster brothers and sisters or children living as brothers and sisters in the same house. When we are able within the school's Published Admission Number (PAN) to offer a place to a child of multiple births (twins, triplets etc) we will offer places to all the children of that birth even if doing so takes the school above its PAN.
- e) **Children of Staff at the School** – Priority will be given to children of a member of staff who has been employed at the school for two or more years at the time at which the application is made and children of a member of staff who has been recruited to fill a vacant post for which there is a demonstrable skill shortage.
- f) **Children with Exceptional Compassionate, Social, Medical/Health or Special Access Needs** – Priority will be given to children under this criterion, which applies equally to such needs of the child's parents or carers, where there is on any of these grounds a demonstrable and significant need to attend the Endowed School. The school will comply with its legal obligations in particular those under the Equality Act 2010. The application must be supported by written evidence from an appropriately qualified person who where there are health or impairment issues must be a qualified medical practitioner. The evidence must demonstrate strong reasons why The Endowed is the most suitable school and the difficulties that would be caused if the child had to attend another school.
- g) **Distance/Nearness of Children's Home to School** - Remaining places will be offered to children according to how near their permanent residence is to the school, with those living closer to the school receiving a higher priority. The distance is measured between the child's permanent home address and the school measured in a straight line using Ordnance Survey address point data. Distances are measured from a point defined as within the child's home to a point defined as within the school as specified by Ordnance Survey. The same address point on the school site is used for everybody. The school uses measurements provided by the Local Authority and further information on how distances are calculated, the definition of a child's home address, and how flats are treated for measurement of distance is available in the Admissions Booklets provided by the Local Authority. In the unlikely event that two or more children live at the same distance from the school and in all other ways have equal eligibility for the last available place at the school, then the names will be issued a number and drawn randomly to decide which child is given the place.

The same oversubscription criteria will be applied for **In Year Casual Admissions** and a supplementary information form will need to be completed in the circumstances outlined below. Any **In Year Application** must be made to the Headteacher.

### ***Applications Procedure for Admission to Year 3 in September 2017***

**ALL** applications for admission **must** be made on the **Junior Common Application Form (JCAF)** which may be obtained from the school office, local infant schools or the Local Authority or you can fill one in online at [www.kent.gov.uk/ola](http://www.kent.gov.uk/ola). It is to be submitted to the Local Authority or any Kent Primary School by **16th January 2017**. **ONLY ONE JCAF SHOWING THE NOMINATED PREFERENCES MAY BE SUBMITTED FOR EACH CHILD; PHOTOCOPIES MUST NOT BE USED.**

**Please note** the following **additional important procedure** where it applies.





Where the parent or carer wishes the child to be considered for admission to the Endowed School under any of the following criteria, Church Faith, Current Family Association, Child of Member of Staff or Exceptional Compassionate, Social, Medical/Health or Special Access Needs, additional information **should** be provided on a **supplementary information form** which may be obtained from the school with the school's prospectus or from the Local Authority. ***This supplementary information form should be returned to the Headteacher of the Endowed School at High Street, Whitstable, Kent CT5 1AY i.e. NOT to the Local Authority or any other school, by 16th January 2017. Failure to complete and return the form may affect the priority rating of the application.*** Where you are not relying on any of these criteria your application will be considered on the information provided by you in the JCAF and there is no need to complete and return the supplementary information form.

**WHERE A COMPLETED SUPPLEMENTARY INFORMATION FORM IS RETURNED THE SCHOOL IS NOT PERMITTED TO TREAT IT AS A VALID APPLICATION UNLESS THE PARENT OR CARER HAS ALSO SUBMITTED BY 16th JANUARY 2017 A COMPLETED JCAF NOMINATING THE SCHOOL AS ONE OF THE PREFERENCES ( SEE ABOVE).**

### ***Late Applications***

The school will use the process set out in the Local Authority's Admission Booklets.

### ***Withdrawal of Places***

After a place has been offered the school reserves the right to withdraw the place in the following circumstances:

1. When a parent or carer has failed to respond to an offer within a reasonable time; or
2. when a parent or carer has failed to notify the school of important changes to the application information; or
3. the admission authority offered the place on the basis of a fraudulent or intentionally misleading application from a parent or carer.

### ***Appeals***

In accordance with the requirements of the Education Acts, the Governors will make arrangements, if required, for parents or carers to appeal to an independent appeal panel against the refusal of a place for their child in the School. Appeals must be lodged by no later than **17<sup>th</sup> May 2017**.

### ***Waiting List***

If a child is unsuccessful in obtaining a place because of oversubscription, the parent or carer may ask for the child's name to be placed on the school's waiting list. Applications must be made **by notifying the Local Authority** by no later than **15<sup>th</sup> May 2017**. On **12<sup>th</sup> June 2017** the Local Authority will, using the school's oversubscription criteria in the same order of priority, reallocate any places that have become available to those who have asked to go on the waiting list. Parents or carers may ask for the child's name to be kept on the school's waiting list should a place become available after 12<sup>th</sup> June 2017. The waiting list will be re-ranked in line with the school's published oversubscription criteria every time a child is added to the list. Waiting lists will be maintained until the end of the relevant academic year of admission. Placing a child's name on the waiting list does not affect the parent's or carer's right of appeal against a refusal to offer the child a place at the school.

***Requests for Admission Outside of the Normal Age Group***

***(This does NOT apply to In Year Casual Admissions for which please see page 2)***

Requests for admission outside of the normal age group should be made to the Headteacher of each preferred school as early as possible in the admissions round associated with that child's date of birth. This will allow the school and admissions authority sufficient time to make a decision before the closing date. Parents are not expected to provide evidence to support their request to defer their application, however where provided it must be specific to the child in question. This might include medical or Educational Psychologist reports. There is no legal requirement for this medical or educational evidence to be secured from an appropriate professional, however, failure to provide this may impede a school's ability to agree to deferral. Parents are required to complete a JCAF application for the normal point of entry at the same time, in case their request is declined. This application can be cancelled if the school agrees to accept a deferred application for entry into Year 3 the following year. Deferred applications must be made via paper JCAF to the LA, with written confirmation from each named school attached. **Deferred applications will be processed in the same way as all applications for the cohort in the following admissions round, and offers will be made in accordance with each school's oversubscription criteria.**
