

- ✓ Quality of communications with the householder or business capturing the recyclate
- ✓ Quality of collection systems deployed
- ✓ Quality of sorting systems MRFs are important
- Quality of recyclate provided to UK reprocessors
- ✓ Quality of enforcement of regulation export and home waste crime – integrity
- ✓ Quality of our health and safety practice
- Quality of information for industry and public transparency

Quality, quality - the overriding theme

# Our work on quality



- End Destination of Recycling Charter designed to focus on what actually happens to recycling and emphasise need for quality for reprocessing
- Reprocessors Roundtables on Quality
- Costs of Contamination Report 2012 2016 draft version with co-operation of sister materials organisations, data was submitted to WRAP for Consistency project – currently reviewing options for further revision
- Resource Association Quality Recognition Awards launched 11<sup>th</sup> July 2017 at our Annual Lecture
- ReQIP Recycling Quality Information Point major project on quality specifications to clearly define what is wanted by a reprocessor

# ReQIP – Recycling Quality Information Point <a href="https://www.resourceassociation.com/regip">www.resourceassociation.com/regip</a>



- Online and updated resource on reprocessor quality specifications
- Over 30 companies and associations provided information, representing nearly 13 million tonnes of UK reprocessing capacity across all main material streams
- Value and Contamination Chart also describes relationship between mixing of certain materials and the impact on value
- We assert that this resource represents 'the necessary quality standards for the relevant recycling sectors' as defined in Article 11, Clause 1, para 2 of the rWFD

### **Current market situation**



- Brexit negotiations and EU: industry uncertainty; CBI position on Single Market and Customs Union we agree with; detrimental effect of tariffs on export markets; technical labour mobility issues; political fragility in UK; Circular Economy Package implementation and UK negotiation positions
- National Sword policy in China: tightening of quality demands; pressure on MRF operators and exporters to achieve quality; displacement of poorer materials to other (smaller) markets; UK market share may decline if quality can't be delivered
- UK resources policy and landscape: Defra hollowed out of staff and swamped by Brexit; Ministerial changes; waste industry-led discussion of EPR for packaging not gaining traction; WRAP evolving into funding-driven projects but some very useful work on Consistency

# **WRAP Consistency Framework**



- Multi-stakeholder involvement in Steering Group
- Framework guidance, non-statutory but supported by Ministers
- Some 'pilot' projects awaiting reports
- Three systems advocated but WRAP themselves stated that multimaterial kerbsort with weekly food and revisions to residual were most cost-effective over long-term
- Critically important for delivering high-quality recyclate to reprocessors and value adding in economy
- Question of timescale and investments transition plan needed?
- Welsh Collections Blueprint provides real-time evidence of effectiveness of this system: 3<sup>rd</sup> highest 'real' recycling rate in world now, high quality delivered

# Raw Material Quality - where now?



- Brexit decision and resultant uncertainty changes the context but not the imperative
  - European Commission's Roadmap for a Resource Efficient
     Europe and subsequent Circular Economy Package are clear on
     high quality separately collected recyclate being essential to
     manufacturing in Europe and the development of the 'recycling
     society'
- Most of the EU maintain extensive bring systems for the key materials defined in rWFD as requiring separate collection - paper, metals, glass, plastics with limited reach of co-mingled collection from households
- The reality is that, despite some technical improvements in MRFs the decline in quality reprocessors have commented on for a decade mirrors the rise of co-mingled collection

### Raw Material Quality – where now?



- MF Regulations need more scrutiny: success of function of EA as regulator?
  - sorting systems need to catch up rapidly and adapt to collection changes
  - fresh thinking in England on the potential for adopting the Welsh Collections Blueprint is essential as contracts are renewed
- Time will tell whether our comparison with EU Member States is relevant in the future – but focus on quality recycling contributing to the circular economy will remain regardless of our EU status
- Current Government uncertainty does not help
  - Govt has other priorities and we remain low in them, even within the Brexit debate
  - New Secretary of State at Defra has a lot to review we need a positive tone about quality and the value of our sector - and he is looking to make his mark
  - It leaves the onus for action on us if we don't lead and work together to optimise our supply chain, others will try and do it for us....

### Where does that leave local authorities...?



- Fully understand the pressures councils face with 'austerity' cuts and competing budgetary demands
- Waste disposal and treatment remains a prominent cost centre for councils
- WRAP Consistency evidence base shows cost savings from current baseline, over a 7-8 year cycle but needs upfront investment – we know this is a challenge
- Are there leasing or lease guarantee models (like the old WRAP eQuip scheme) that could ease the upfront demands and make this more attractive to councils?
- Little in the way of strong steer from Government shouldn't be allowed to get in the way of continuing to strive for best environmental performance, resource savings and customer service for residents
