
Engineering Ltd on a two stage Early

stage will be to support KCC in the
completion of the detailed design, with
Jackson able to bring their extensive
expertise to mitigate some of the risks
before we start the second stage
construction phase. Jackson have a long

Public Exhibitions

Two public exhibitions have been arranged where people can meet the project team to get an update on the project and initial proposals for the construction phasing and programme. Project Update

Previous Public Engagement

The feedback from the public engagement held in December 2015 gave us an important insight into local concerns. Where possible these are being considered further as we finalise the detailed design of the project over the next few months.

Some of the main local concerns that we are considering include:

- Noise and air quality impacts both permanent and during construction
- Location and specific detail regarding the noise mitigation fencing
- Parking issues in Loudon Way
- Operation of the Loudon Way signal junction
- General impacts of the construction works
- Concerns regarding the movement of traffic through the Cobbs Wood Estate
- Improved destination signing/road markings on the approaches to roundabouts

Funding Confirmed

£10.2m of Local Growth Funding had already been secured from Central Government for the £32.8m scheme and the approval of the planning application for the Chilmington Green development has confirmed the remaining £22.6m funding through developer contributions.

Land

Discussions are ongoing with landowners regarding the acquisition of land required for the scheme but in order to safeguard the construction programme a Compulsory Purchase Order was published in May 2017. It is anticipated that all land required for the scheme will be secured before January 2018. However, should voluntary land acquisition not be possible and we have to use our compulsory purchase powers, then the start of the scheme may be delayed until 2019.

Site Investigations

Over the next few months you may see some additional site surveys and investigations being carried out by Jackson, as we gather more detailed information about the site to mitigate the construction risks. These include further trial holes to confirm ground conditions and position of utility apparatus, additional drainage surveys and ground investigations in the vicinity of the new railway bridge.
