

IDE HILL CHURCH OF ENGLAND PRIMARY SCHOOL GOVERNING BODY ADMISSION POLICY FOR ACADEMIC YEAR SEPTEMBER 2017

Our current Published Admission Number for September 2017 is 20.

The admission area for Ide Hill Church of England Primary School is the area within a radius of 2 miles of the school as shown on the Ordnance Survey map available at the school (see note 1).

NB: In addition to the Local Authority Application Form, Ide Hill Church of England Primary School requires a Supplementary Form to accompany every application which must be returned DIRECTLY to the school. <u>Failure to submit this supplementary form WILL adversely affect your application.</u>

The supplementary form can be downloaded from the school website: www.idehillschool.org or a paper copy may be obtained from the school office.

Admission Criteria

Before the application of oversubscription criteria, children with a statement of special educational need or Education (SSEN), Health and Care plan (EHCP) which names the school will be admitted. As a result of this, the published admission's number will be reduced accordingly.

If the school is over-subscribed, the governing body will apply the following criteria in the following order:-

- 1. Children in Local Authority Care or previously in Local Authority Care (see note 2)
- 2. Children with siblings attending the school at time of application (see note 3)
- 3. Children who live within a one mile radius of the school (see note 1)

In the event of over subscription for either of these criteria then, as a Christian School, preference will be given first to those whose parents / guardians are worshippers at a Church of England Church, and secondly to those who are worshippers at another Christian Church. This is not dissimilar to other church schools admission criteria (see note 4).

- 4. Children who live in the admission area and whose parent(s)/guardian(s) are worshippers at their Church of England Parish Church.
- 5. Children who live in the admission area and whose parent(s)/guardian(s) are worshippers at other Christian Churches.
- 6. Children who live within the admission area, whose parent(s)/guardian(s) are not church worshippers, but would like their child to be educated at a Church Aided School.
- 7. Children who live outside the admission area whose parent(s)/guardian(s) are worshippers at their Church of England Parish Church.
- 8. Children who live outside the admission area and whose parent(s)/guardian(s) are worshippers at other Christian Churches.
- 9. Children, who live outside the admission area, whose parent(s)/guardian(s) are not church worshippers but would like their child to be educated at a Church Aided School.

Tie-breaker: In the event of a tie-breaker, where we have to choose between two or more children in the same category as each other, with the same distance from home to school (as measured by the LA), a decision will be made by drawing lots, which will be carried out by the Admissions Committee, in the presence of an independent witness.

Notes:

1. **Distance** - The distance is calculated 'as the crow flies'; the order of priority will be based on the nearness of home to school with those living nearer having priority. The school uses measurements provided by the LA and further information on how distances are calculated is available in the Admissions Booklets provided by the LA.

- 2. Children in Local Authority Care or previously in Local Authority Care a child under the age of 18 years for whom the local authority provides accommodation by agreement with their parents/carers (Section 22 of the Children Act 1989) or who is the subject of a care order under Part IV of the Act. This applies equally to children who immediately after being looked after by the local authority became subject to an adoption, residence or special guardianship order. (As defined by Section 46 of the Adoption and Children Act 2002 or Section 8 or 14A of the Children Act 1989.)
- 3. Siblings children who live as brother and sister in the same house, including natural brothers or sisters, adopted siblings, stepbrothers or sisters and foster brothers or sisters.
- 4. Where the word "worshippers" at a church is used in the criteria, this is to be understood as the affirmation by parent(s)/ guardian(s) of regular attendance at church worship, and requires endorsement by the Priest/Minister of the attended church.

Admission Procedures

- 1. Closing Date The closing date for applications for admissions and the offering of places will be in line with that of the Local Authority. Supplementary forms MUST be returned to the school office by the same date. Applications received after this date will be considered in relation to the admissions criteria only if there are spaces. Parents and guardians should note that gaining a place is not dependent on how early the application was made.
- 2. Waiting List Children not offered a place will be put in order on the waiting list in accordance with the admissions criteria, not on a first come first served basis. The waiting list will be re-ranked, in line with the published oversubscription criteria, every time a child is added. The waiting list will remain in operation until the end of the first term (i.e. October half term).
- 3. Notification of Decision The Local Authority will inform parents and guardians whether a child has gained a place at this school.
- 4. Right of Appeal If the child has not gained a place at the school and the parents or guardians wish to appeal against that decision, they should first contact the headteacher who will tell them how to proceed.
- 5. Statutory School Age / Deferred Entry The statutory age at which a child must start school is the beginning of the term after which they become five. However, a place will be provided for children in the September following their fourth birthday. Parents of children who are offered a place at the school before they are of statutory school age, may defer their child's entry until later in the school year. When entry is deferred, a place will be held for that child, but must

be taken up at the beginning of the term after which the child reaches statutory school age. However, the place cannot be held beyond the academic year for which the original application was accepted.


- 6. Full/Part Time basis Parents of children aged four will be able to chose for their child to start school on a full or part time basis (after discussion of specific needs with the Head teacher), however children are required to attend full time in the term they become five.
- 7. In Year Admissions Anyone wishing to apply for a place within the academic year must complete an "In Year Admissions Form". Where the pupil numbers of the year group are over the Published Admission Number, this will be at the discretion of the Headteacher and Governors.
- 8. Admission out of the normal age group - Places will normally be offered in the Year Group according to the child's date of birth but a parent may submit an application for a Year Group other than the child's chronological Year Group, for instance where the child is gifted or talented or where a child has suffered from particular social or medical issues impacting his or her schooling. We shall make a decision on the basis of the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views; information about the child's academic, social and emotional development where relevant; their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. We shall also take into account the views of the Headteacher of the school. Parents must not assume that the decision of one school will transfer with the child to a different school as the decision rests with the individual admission authority. Where a place is refused in a different Year Group but a place is offered in the school, there will be no right of appeal.
