<u>Facts and figures about</u> <u>Kent</u> This bulletin presents 2021 Census data about residents in Kent and Kent districts who have previously served in the UK armed forces. Comparisons with Medway, the South East, and England & Wales are included.

Headlines

- There were 52,545 UK armed forces veterans living in Kent in 2021.
- 88% of Kent's UK armed forces veterans were male, and 57.9% were aged 65 and over.
- 37.2% of Kent's veterans were not in good health, above the national (35.6%) and the regional (33.8%) averages. 32.6% of veterans were disabled under the Equality Act.
- At 38.7%, Kent had a lower proportion of veterans who were economically active than was seen nationally (42.4%) and regionally (40.4%). Of those who were economically inactive 89.9% were retired.
- 97.9% of Kent veterans were living in households while 2.1% were resident in communal establishments.

Introduction

On 10th November 2022, the Office for National Statistics (ONS) published data from the 2021 Census about UK armed forces veterans in England and Wales. In Spring 2023 multivariate data was released allowing us to look at the characteristics of armed forces veterans.

This is the first time that the census has asked a question about UK armed forces veterans.

The Census 2021 results about UK armed forces veterans include data about people who have previously served in the regular forces, reserve forces or both.

Service providers will use these data to support veterans in line with the Armed Forces Covenant. The Armed Forces Covenant is a national responsibility involving government, businesses, local authorities, charities, and the public, and promises to ensure that those who serve or who have served in the armed forces, and their families, are treated fairly. The covenant focusses on helping members of the armed forces community have the same access to government and commercial services and products as any other citizen.

Analysis

The 2021 Census tells us that there were 52,545 UK armed forces veterans living in Kent in 2021 accounting for 4.1% of the resident population aged 16 and above. This was above the national average of 3.8% and slightly lower than the regional figure of 4.2%.

In Kent the largest number of UK armed forces veterans were in Thanet (5,765 veterans) accounting for 11% of all veterans in Kent. Dover had the highest proportion of UK armed force veterans with 5.9% of the resident population aged 16 and above having served at some time in their life.

Dartford (2,328) and Gravesham (2,351) had the smallest number of veterans in Kent accounting for 2.6% and 2.8% of the respective adult populations.

Table 1 shows the number and proportion of residents in Kent and Kent districts who were UK armed forces veterans in 2021. Chart 1 shows the proportion of residents aged 16 and above who were UK armed forces veterans.







In Kent 3.2% of the population aged 16 and above previously served in regular UK armed forces, the same as seen in the South East and above the national figure of 2.9%.

0.8% of the adult population in Kent had previously served in reserve UK armed forces (South East 0.8%, England and Wales 0.7%) and 0.2% had previously served in both regular and reserve armed forces (also 0.2% in both England and Wales, and the South East).

95.9% of the adult population in Kent had never served in any UK armed forces.

In Kent the largest number of veterans who had served in regular UK armed forces lived in Dover (4,638). The largest number that had served in reserve UK armed forces (1,053) or in both regular and reserve UK armed forces (256) lived in Maidstone. This is shown in Chart 2.

Chart 2: Number of UK armed forces veterans in Kent & Medway in 2021



In Kent, those veterans who had previously served in only the regular UK armed forces accounted for 76.8% of all veterans living in the county. This was slightly lower than the regional figure (77.3%) and slightly higher than the national figure (76.3%).

Dover had the highest proportion of veterans who had previously served in only the regular UK armed forces (81.2%).

Veterans who had previously served only in the reserve UK armed forces made up 18.9% of Kent's veteran population (South East 18.4%, England and Wales 19.5%).

Dartford had the highest proportion of veterans who had previously served only in the reserve UK armed forces (24.0%).

Veterans who had previously served in both the regular and the reserve UK armed forces made up 4.3% of Kent's veteran population, the same as seen regionally and nationally.





Gravesham had the highest proportion of veterans who had previously served in both the regular and the reserve UK armed forces (5.0%).






Chart 3: Proportion of veterans who have previously served in the regular, the reserve, or both the regular and reserve UK armed forces

Households with UK armed forces veterans

As of Census Day 2021, 7.7% of households in Kent had at least one veteran living there. 7.4% had one UK armed forces veteran resident, 0.3% had two veteran residents. 0.01% had three or more veteran residents.

Table 5 and Table 6 show the number and proportion of households in Kent and Kent districts compared to the national and regional figures, split by how many veterans were living in those households.

UK armed forces veterans by sex

Many who have previously served in the UK armed forces will be older males because of National Service. National service in peace time meant that between 1949 and 1960 all physically fit males between the ages of 17 and 21 had to serve in one of the armed forces for an 18-month period.

In Kent 88.0% of veterans were male, and 12.0% were female at the time of the Census. There was a higher proportion of male veterans and a lower proportion of female veterans than seen both regionally and nationally.

All districts in Kent had a higher proportion of male veterans and a lower proportion of female veterans than the regional and national average.

Dover had the highest proportion of female veterans (13.3%) while Ashford had the highest proportion of male veterans (89.6%).

UK armed forces veterans by age

In Kent more than half of all veterans were aged 65 or over, and more than three quarters of veterans were aged 55 or over. Kents veteran age distribution was similar to that of the South East region however, compared to England and Wales, Kent had a greater percentage of veterans aged 75 or over.

In Kent there were 30,447 veterans aged 65+, accounting for 9.5% of the 65+ population. This was slightly higher than the 8.9% of the England and Wales 65+ population that were veterans.

Tables 8 and 9 show the number and proportion of armed forces veterans by age group in Kent and Kent districts, with regional and national comparisons.



UK armed forces veterans by general health

In Kent, 37.2% of veterans were not in good health, which was higher than the figure for the South East (33.8%) and England and Wales (35.6%). The proportion of veterans that were not in good health was higher than that of non-veterans in England and Wales, and this was reflected in the proportions for the South East and the Kent districts.

Thanet had the highest number and proportion of veterans not in good health, with 2,454 (42.5%) veterans. Dover had the second highest number of veterans not in good health with 2,156 (38.1%), whilst Gravesham had the second highest proportion at 42.1% (990 veterans).

Ashford had the highest proportion of veterans in good health, with 66.6% (3,305 veterans), followed by Tunbridge Wells (65.7%, 2,098 veterans). Maidstone had the highest number of veterans in good health, 3,643 veterans (64.3%).

Tables 10 and 11 show the number and proportion of veterans and non-veterans based on whether they were or were not in good general health. Chart 5 shows the proportion of veterans not in good health compared to non-veterans.



UK armed forces veterans by disability

Kent had a slightly higher proportion of veterans with disabilities compared to England and Wales and compared to the South East region (32.6% in Kent compared to 30.5% in the South East and 32.1% in England and Wales).

Within Kent, Thanet had the highest number and proportion of disabled veterans, with 2,139 veterans (37.1%). With Dover (1,943 veterans) and Canterbury (1,766 veterans) having the second and third highest numbers.

Tables 12 and 13 overleaf show the number and proportions of UK armed forces veterans with and without disabilities, along with the split of how those with disabilities are impacted in day-to-day activities.



In Kent, a much higher proportion of veterans had disabilities (32.6%) compared to nonveterans (19.7%). In particular, the proportion of veterans with a disability which limits dayto-day activities a lot was double that of non-veterans in Kent. This trend was also seen in England and Wales and the South East region.

Thanet had the highest proportion of disabled veterans and disabled non-veterans.



UK armed forces veterans by economic activity status

A person will be economically active if they are in employment or unemployed and available to work. A person would be economically inactive if they were neither working nor looking for work.

Kent had a slightly lower proportion of economically active veterans (38.7%) compared to England and Wales (42.4%) and the South East region (40.4%). This could possibly be explained by the fact that Kent had a higher proportion of veterans aged over 65.

In Kent, Maidstone had the highest number of veterans who were economically active while Ashford had the highest proportion (45.1%).

Thanet had the highest number and proportion of economically inactive veterans (3,869, 67.0%).

Of those veterans in Kent who were economically active, 96.4% were in employment and 3.6% were unemployed (seeking work or waiting to start a job already obtained: Available to start working within 2 weeks).

Tunbridge Wells had the highest proportion that were in employment (97.3%) while Thanet had the lowest proportion (94.6%).

UK armed forces veterans by occupation

19,618 UK armed forces veterans in Kent were in employment at the time of the Census. The most common type of occupation in Kent was associate professional and technical occupations, with 17.4%, closely followed by managers, directors and senior officials at 16.6%. Sales and customer service occupations were the least common type of occupation for veterans, making up just 3.4% of jobs.

UK armed forces veterans by resident type

97.9% of UK armed forces veterans in Kent were household residents. This was similar to the proportion seen nationally (98.0%) and in the South East (97.6%).

1,095 veterans in Kent were communal establishment residents and accounted for 2.1% of all veterans living in Kent. A communal establishment is an establishment providing managed residential accommodation providing full-time or part-time supervision of the accommodation. Communal establishments include hospitals, care homes, prisons, defence bases, boarding schools, and student halls of residence.

Thanet had the largest number of UK armed forces veterans living in households (5,663), Maidstone had the largest number living in communal establishments (151).

UK armed forces veterans by tenure

In Kent, 76.3% of households with one or more veterans owned the property they were living in, with 51.5% owning the property outright. Both of these proportions are larger than those for England and Wales, however slightly lower than that of the South East region.

Of the 23.7% of households containing veterans which were renting, there was almost an even split between social renting and private renting or rent free.
