## Application for Admission to Saint George's Church of England School (Secondary) For September 2025

The Published Admission Number for 2025 is 210

All parents/guardians applying for places for their children at Saint George's Church of England School are expected to support the Christian ethos and practice of the school. As a comprehensive school Saint George's C of E School admits students from the whole range of academic ability. Completion of the Supplementary Information Form is not mandatory. However, if one is not received, the Governors will not be able to apply their admissions criteria, and the application will be considered as a lower priority. The Supplementary Information Form should be returned directly to the School. A copy of the Supplementary Information Form may be either downloaded from the school website <http://www.saintgeorgescofe.kent.sch.uk/school-info/admissions/> or obtained directly from the school. The Supplementary Information Form must be returned to the school no later than 31 October 2024.

Before the application of oversubscription criteria, children with a statement of special educational need or Education, Health and Care Plan which names the school will be admitted. A Statement of Special Educational Need is a statement made by the local authority under Section 324 of the Education Act 1996 specifying the special educational provision required for that child. An Education, Health and Care plan is a plan made by the local authority under Section 37 of the Children and Families Act 2014 specifying the special education provision required for that child. As a result of this, the published admissions number will be reduced accordingly.

## Further Information

If there are more applications to Saint George's C of E School than there are places the following oversubscription criteria will be applied by the Governors.

### **1. Children in Local Authority Care or Previously in Local Authority Care**

a 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order. A looked after child is a child who is:

(a) in the care of a local authority,

or

(b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

This includes children who appear to have been in state care outside of England and have ceased to be in state care due to being adopted.

### **2. Children who are currently attending Saint George's C of E School in year 6** (school code 5404).

### **3. Children who have a sibling or step or half siblings including fostered and adopted siblings living at the same home address attending Saint George's School at the time of admission.**

The school reserves the right to ask for proof of relationship.

### **4. Children or one of whose parents/grandparents/guardians is:**

a. A regular worshipper at a Church of England church. This would be monthly attendance for a period of at least 1 year. The appropriate priest, minister or religious leader will be required to confirm this on this Supplementary Information Form at the time of application.

or

b. A regular worshipper at a church which is a member of Churches Together (<https://www.cte.org.uk/>) in England or the Evangelical Alliance

**5. Children of staff in either or both of the following circumstances:**

- a. where the member of staff has been employed at the school two or more years at the time at which the application for admission to the school is made,
- b. and/or the member of staff is recruited to fill a vacant post in the school for which there is a demonstrable skill shortage for the requirements of the post.

**6. Children who attend an Aletheia Academies Trust (AAT) primary school throughout years 5 and 6.**

**7. All other applicants.**

are not available, measurements will be determined by a Senior Admissions Officer and confirmed by Head of Service.

There will be a right of appeal to an Independent Appeals Panel for unsuccessful applicants, whether they are an internal or external applicants.

## Notes:

An applicant applying under criterion 4 will be one whose family attends at least monthly. The worshipper may be the child for whom application is made or one or both parents/grandparents/guardians.

Requests for admission to Year 7 outside of the normal age group should be made to the Headteacher of each preferred school as early as possible in the admissions round associated with that child's date of birth. This will allow the school and admissions authority sufficient time to make a decision before the closing date. Parents are not expected to provide evidence to support their request to defer their application, however where provided it must be specific to the child in question. This might include medical or Educational Psychologist reports. There is no legal requirement for this medical or educational evidence to be secured from an appropriate professional, however, failure to provide this may impede a school's ability to agree to deferral. Parents are required to complete an application for the normal point of entry at the same time, in case their request is declined. This application can be cancelled if the school agrees to accept a deferred application for entry into year 7 the following year. Deferred applications must be made via paper SCAF to the LA, with written confirmation from each named school attached. Deferred applications will be processed in the same way as all applications for the cohort in the following admissions round, and offers will be made in accordance with each school's oversubscription criteria. ## Arrangements for admission to Post-16 Provision

The minimum entrance requirements for the Sixth Form and for the range of courses available are based upon GCSE grades or other measures of prior attainment. To gain entry to the Sixth Form applicants will need to have achieved:

- Grade 4 or better in Mathematics
- Grade 4 or better in either English Literature or English Language
- At least 5 grade 9 - 5 in GCSE or equivalent subjects
- The specific entry requirements for each A level that the applicant wishes to study. These are published on the school's website and are available directly from the school.

These criteria are the same for internal and external transfers. All internal applicants who meet the criteria will be admitted to the Sixth Form, even if this number is greater than the planned admissions number. The entry criteria will be published in the autumn immediately preceding the year of admissions (that is autumn 2024) for September 2025 admissions. The criteria will be included within the Sixth Form prospectus and on the school website. If 120 or more students from within Saint George's School meet the admissions criteria and wish to enter year 12 of the Sixth Form, no external applicants will be considered.

Applications to the Sixth Form need to be made online using <https://www.ucasprogress.com/search>. Following an application, a reference will be sought from their current school. Successful applicants will be offered a conditional place that is dependent on them attaining the entry criteria in the actual GCSE exams. Numbers are limited in subjects and where this number has been met alternative subjects may be offered.

Where there are more external applicants for any available Sixth Form places than places available, after the admission of students with special educational needs where the school is named on the statement, the following criteria will be applied.

**1. Children in Local Authority Care or Previously in Local Authority Care**

A child under the age of 18 years for whom the local authority provides accommodation by agreement with their parents/carers (Section 22 of the Children Act 1989) or who is the subject of a care order under Part IV of the Act. This applies equally to children who immediately after being looked after by the local authority became subject to an adoption, residence or special guardianship order. (As defined by Section 46 of the Adoption and Children Act 2002 or Section 8 or 14A of the Children Act 1989). This includes children who appear to have been in state care outside of England and have ceased to be in state care due to being adopted.

**2. Students in receipt of Pupil Premium: A student is eligible for Pupil Premium where they have been registered for free school meals (FSM) at any point in the last 6 years.**

This does not include students who have only been eligible to receive Universal Infant Free School Meals. This will be confirmed on the reference received from the applicant's current school.

**3. Children who have a sibling or step or half siblings including fostered and adopted siblings living at the same home address attending Saint George's C of E School at the time of admission.**

The school reserves the right to ask for proof of relationship.

**4. Children of staff in either or both of the following circumstances:**

- a. where the member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made,
- b. and/or the member of staff is recruited to fill a vacant post in the school for which there is a demonstrable skill shortage for the requirements of the post

Where two or more children have an otherwise equal priority under the oversubscription criteria random selection will be used to establish which is ranked ahead of the other.
