Who are we?

- We are Kent County Council. We look after public services which support people in Kent.
- Kent County Council's Public Health department work to support protecting and improving the health of Kent's population.
- We work with Kent Community Health NHS Foundation Trust. Our aim is to help people have healthy teeth and mouths.



Why do we use your information

- We are required by law to provide health and social care services. This means we are covered by law to use your information. We do not always have to ask for your permission to use your information.
- We will only share information when we need to do so and with people who need to know. We have security in place to stop information being used in the wrong way.
- We also have to make sure we follow data protection laws. This is the UK General Data Protection Regulation. This means we have to

provide certain information to you. We use this privacy notice to keep you updated.



What information will we use?

- We will use your personal information. This can include your name, email address, and place of work.
- We may collect this information from you, other organisations who look after your health or people that may know you.
- We use this information to keep a list of Oral Health Champions. This helps us send you training and resources.
- This means we only use information for these purposes only.



Who will we share your information with?

- We will only share information to organisations who will help you to look after your health and social care.
- This can include Kent Community Health NHS Foundation Trust
- We may also share information that has your personal details removed. This helps us to keep track of how well we are doing and what we can do to improve.

- We may also need to share your personal information with the Police, the Courts etc. if we are asked to by law.





How long do we keep your information for?

- We can only keep information for as long as we need it.
- We keep your information until you tell us you no longer want to be an Oral Health Champion or when we find out you are no longer in the role.
- We check regularly to make sure we only keep information that is useful to us.



What are my rights?

- You have rights under the UK General Data Protection Regulation. They are:
- know what we are doing with your information and why we are doing it
- ask to see what information we hold about you
- ask us to correct any mistakes in the information we hold about you
- object to direct marketing
- make a complaint to the UK Information Commissioner
- We will let you know if there have been any breaches to your
