Important: all data in this publication is derived from three main sources as follows: -

- Kent County Council is the primary source for tonnage information and residual waste destinations.
- Waste Data Flow in terms of summary information on data input by the 13 councils.
- Waste management companies in relation to countries of end destinations and quantities.

The Kent Resource Partnership staff are entirely reliant on these sources and do not, and can not, produce original data themselves.

NOTE 1

For this financial year, some dry-recycling tonnage from the 13 Kent councils was processed through Materials Recycling Facilities (MRFs) or with companies who may send their feedstocks abroad (e.g. wood for biomass). The KRP thanks Countrystyle Recycling Ltd, FCC Environment, Greenstar Environmental Ltd (Biffa), Ideal Waste Paper Co Ltd, Valpak Recycling Ltd, Veolia ES Cleanaway (UK) Ltd and Viridor Waste Kent Ltd for the provision of information to us about the countries of end destination of their outputs. The KRP is very grateful for the co-operation shown. There were no companies who refused to provide details of countries of end destinations when asked by the KRP.

NOTE 2

On the basis of industry experience for tonnages via charities, we have allocated tonnages 'abroad'. This includes items (e.g. clothes) that are collected by UK based charities and re-used by people in other countries.

NOTE 3

On advice from Kent County Council on destinations of materials to companies listed on pages 36 & 37, 80% is treated as being in Kent, 10% other UK and 10% abroad.

NOTE 4

Waste Data Flow publishes information for 'Kent County Council' even though this is an amalgamation of all 13 Kent councils' information. Thus, the information for Kent Resource Partnership on pages 6 to 11 also incorporates all tonnages for Kent County Council.

Note 5

Every effort has been made to ensure the figures in this publication are correct. However, as the figures are based heavily on information from the national Waste Data Flow system, factors that impact on calculations are very likely to be replicated in this publication. Additionally, if the publication includes an inadvertent error, we would be pleased to be advised. Foreword

2014/15 is the fourth year for which the Partnership has compiled data on the end destinations of materials. Our motivation is that openness and transparency with our residents is the surest way to gain and retain their confidence in our high-achieving, recycling and waste resource services across Kent.

For 2014/15 the total household materials collected by the 13 Kent councils was just over 711,000 tonnes, a small, 1.8% increase on the previous year. This is in line with the increased national trend on household tonnage, related to the growing economy. There is a continuing need for further collaborative work between councils, residents, retailers, producers, and others to minimise waste – with a particular emphasis on avoidable food waste.

Around 90% of Kent's household waste tonnage was reprocessed within the UK and the vast majority – nearly three-quarters of all tonnage – was treated in Kent. Just 10% of Kent's household waste is sent abroad by waste companies with the majority being reprocessed within Europe.

We are pleased to announce that the Partnership's collective recycling rate for 2014/15 was 45.6%, surpassing our 45% recycling target for 2015/16 a year ahead of our ambitious plans. The Partnership recognises there are continuing pressures on weight-based dry recyclate targets; not least from positive environmental changes such as the light-weighting of packaging. We will therefore continue to work together to maximise the capture of recyclable resources across Kent.


Diversion of household waste from landfill continues to be a major priority for the Partnership. In 2014/15 we achieved the biggest single-year reduction since we started publishing the End Destinations Annual Report; a cut of 7 percentage points. This takes our landfill figure to just 11%, and places us within striking distance of the Partnership's collective objective of sending no more than 10% of Kent's discarded materials to landfill by 2015/16. Our medium term goal remains that no more than 5% be landfilled by 2020.






