SCHOOL ADMISSIONS CONSULTATION FOR 2022 – 2023

As the Admissions Authority for St Bartholomew's Catholic Primary School, we are required to consult on our admissions arrangements when there are significant changes and/or at least every seven years.

We believe that it is important for all stakeholders, including prospective parents and carers to understand how our school manages the admissions process.

This policy will be implemented for entry in September 2022 and in-year admissions for the school year 2022 – 2023 and will operate until further notice.

We have made no significant changes to our policy during the last seven years other than the recent temporary addition in regard to Mass attendance which is in place during the present Covid19 Pandemic. Our PAN number will remain at 50.

The consultation will run for at least 6 weeks from 14th December 2020 until 31st January 2021.

Consultation process

St. Bartholomew's Governing Body is its own admissions authority for St. Bartholomew's Catholic Primary School

Every seven years, an admissions authority is required to conduct a full stakeholder consultation process, even if there have not been any changes to the admission policy.

The School Admissions Code and the Code of Practice require admission authorities to consult on their admission arrangements and any supplementary information form whenever significant changes are proposed to the admission arrangements. It is also a requirement to consult at least once every seven years even if there have been no changes during that period.

We are therefore required to undertake a public consultation on our Admissions Policy 2022-23. In accordance with the School Admissions Code the consultation period must run for a minimum of six weeks and take place between 1 October 2020 and 31 January 2021.

St. Bartholomew's Catholic Primary School's consultation period will run from 14 December 2020 to 31 January 2021.

The admissions authority must determine admission arrangements by 28 February 2021 and publish these on its website by 15 March 2021.

Who can be involved in the consultation?

We invite comments from the following groups:

- parents of children between the ages of two and eighteen
- other persons in the relevant area who in the opinion of the admission authority have an interest in the proposed admissions
- all other admission authorities within the relevant area (except secondary schools)
- whichever of the governing body and the local authority who are not the admission authority
- any adjoining neighbouring local authorities where the admission authority is the local authority

• the body or person representing the religion or religious denomination.

Our reason for consultation

This consultation is in accordance with the School Admissions Code and Code of Practice which states consultations are mandatory at least once every seven years, even if there have been no changes to admissions arrangements. There are no proposed changes to the admission arrangements for 2022-23 and St Bartholomew's Catholic Primary School will retain its PAN of 50.

St. Bartholomew's Primary School Admissions Policy and Procedures

St. Bartholomew's Catholic Primary School is a voluntary aided school in the Diocese of Southwark. It is in the trusteeship of the Diocese. The school is conducted by its governing body as part of the Catholic Church in accordance with its Trust Deed and Instrument of Government, and seeks at all times to be a witness to Jesus Christ. The school exists primarily to serve the Catholic community and Catholic children always have priority of admission. However, the Governing Body welcomes all applications, particularly from those of other denominations and faiths who support the religious ethos of the school.

Having consulted with the Local Authority and other admission authorities, the Governors intend to admit into the Reception class, in September 2021, up to 50 pupils without reference to ability or aptitude.

Where the number of applications exceeds 50, the Governors will offer places using the following criteria in the order stated:

Statement:

Admissions Clarification (Covid-19)

Parents and carers applying for places in Years R to 6 in the academic year 2021-2022 are asked to note the following statement in relation to the Mass Attendance oversubscription criterion set out in St Bartholomew's admission arrangements:

On the advice of the Education Commission of the Archdiocese of Southwark, the governing body of St Bartholomew's Catholic Primary School has agreed the following statement in order to clarify how its faith-based oversubscription criteria will be interpreted while churches are closed or attendance at church is not possible due to Covid-19. This statement has been shared widely with parishes by the Education Commission in order to ensure that determinations made by parish priests concerning regular practice of the faith are being made on a consistent basis.

The suspension of the obligation to attend Sunday Mass was announced on 18th March 2020 by the Bishops' Conference of England and Wales. If a parent or carer attended Mass at a particular parish (or parishes) prior to 18th March 2020 then they will be considered to have attended Mass in that parish (or parishes) regularly since that time. This will remain the case until the Sunday obligation is reintroduced by the Bishops.

- Looked after Catholic children or looked after children in the care of catholic families and
 previously looked after catholic children who have been adopted or who have become the subject
 of a residence or guardianship order. Where the last remaining place is to be allocated and two
 or more children are deemed to live at the same distance from the school the place will be decided
 by the drawing of lots.
- 2. Baptised Catholic children. Evidence of Baptism will be required.
- 3. Children enrolled to be baptised. Evidence of enrolment will be required.
- 4. Other Looked after children and other previously looked after children who have been adopted or who have become the subject of a residence or guardianship order.

- 5. Children who are members of Eastern Orthodox Churches. Evidence of Baptism will be required.
- 6. Children of families who are members of other Christian denominations that are part of Churches Together in England. Evidence of Baptism (or dedication) provided by a priest or minister of a designated place of worship will be required.
- 7. Children of other faiths. Evidence of membership of the faith provided by a priest, minister or religious leader of a designated place of worship will be required.
- 8. Any other children.

The following order of priorities will be applied when applications within any of the above categories exceed the places available and it is necessary to decide between applications

- 1. For Category 2 above The strength of evidence of commitment to the faith as demonstrated by the level of the family's Mass attendance on Sundays. This evidence must be provided by the parents/carers and be endorsed by a priest at the church(es) where the family normally worship. Applications will be ranked in the order shown on the Supplementary Form. Firstly weekly Mass, then at least once a month etc. (Please see statement above which applies during Covid-19 pandemic.)
- 2. We give priority to brothers and sisters already on roll at St. Bartholomew's School in line with the above admissions criteria. In this context brother or sister means:
 - (a) Natural brother or sister (including adopted siblings).
 - (b) Step-brother or sister
 - (c) Foster brother or sister
 - (d) Those who live as brother or sister in the same house.
 - still lives at the same address as when the first child was offered a place

or

- has moved closer to the school than when the first child was offered a place,

In the case of children from multiple births, in the event that they are the 30th and 31st pupils will be treated as 'excepted pupils' which would allow the school to run with a class of over 31 without breeching infant class size legislation.

- 3. Medical needs which make the school particularly suitable for the child or parent/carer in question. Strong and relevant evidence must be provided by an appropriate professional authority
- 4. Distance from home to school. Evidence of residence may be required. We use the distance between the child's permanent home address and the school, measured in a straight line using the National Land and Property Gazetteer (NLPG) address point data. Distances are measure from a point defined as within the child's home to a point defined as within the school as specified by NLPG. The same address point on the school site is used for everybody. Where the last remaining place is to be allocated and two or more children are deemed to live at the same distance from the school the place will be decided by the drawing of lots.

Applications procedure

In addition to the Common Application Form (CAF) supplied by the Local authority, the Supplementary Information form (available from the school and from the local authority) should be completed and sent to the secretary at the school not later than 15th January, 2021. This should be done even if the CAF is completed online. If the Supplementary Information Form is not completed the governing body of the school will only be able to consider the application after all applicants who have completed a Supplementary Information Form. You are advised to make two copies of the forms. You should retain one copy and pass the second copy to the school or your priest, as indicated. We will also require sight of your child's baptismal certificate if this is available.

Appeals

Parents whose applications for places are unsuccessful may appeal to an Independent Appeal Panel set up in accordance with sections 94 of the School Standards and Framework Act 1998. Appeals must be made in writing and must set out the reasons on which the appeal is made. Appeals should be made to the Admissions Appeal Clerk at the school address. Parents/Carers have the right to make oral representations to the Appeal Panel.

Waiting List

Parents of children who have not been offered a place at the school may ask for their child's name to be placed on a waiting list. The waiting list will be maintained until such time as the parents or carers no longer wish their child's name to be held and will be operated using the same admissions criteria listed above, Placing a child's name on the waiting list does not guarantee that a place will become available. This does not prevent parents from exercising their right to appeal against the decision not to offer a place. It is possible that, when a child is directed under the local authority's fair access protocol they will take precedence over those children already on the list.

Admission of children below compulsory school age.

The governors will provide for the admission of all children in the September following their fourth birthday. Parents can request that the date their child is admitted to the school is deferred until later in the school year or until the child reaches compulsory school age in that school year; parents may also request that their child attends part-time until the child reaches compulsory school age.

In-year admissions

Applications for in-year admissions are made directly to the school.

If a place is available and there is no waiting list the local authority will be informed and the child will be admitted. If more applications are received than there are places available then applications will be ranked by the governing body in accordance with the oversubscription criteria, with the following modifications: Catholic children without an offer of a school place elsewhere are given priority immediately after Catholic child in Care Children, Child in Care children in the care of Catholic families and previously Child in Care Catholic children who have been adopted; similarly, other children. Child in Care children in the care of Catholic families and previously Child in Care after Catholic children who have been adopted.

If a place cannot be offered at this time then you may ask us for the reasons and you will be informed of your right to appeal. You will be offered the opportunity of being placed on a notice of interest list., the notice of interest list will be maintained by the governing body in the order of the oversubscription criteria (as modified above) and not in the order in which the applications are received. Names are removed from the list at the end of each academic year. When a place becomes available, the governing body will decide who is at the top of the list.

Pupils with a Statement of Special Educational Needs or Education, Health and Care (EHC) Plan

The admission of pupils with a statement of Special Educational Needs or with an EHC Plan are dealt with by a completely separate procedure. The procedure is integral to the making and maintaining of Statements and EHC Plans by the pupil's home Local Authority. Details of this separate procedure are set out in the SEND Code of Practice. Pupils with a Statement or EHC Plan naming the school will be admitted without reference to the above criteria.

Admission of children outside their normal age group

Parents who are seeking a place for their child outside of their normal age group, e.g., the child has experienced problems such as ill health or the parents of a summer born child choosing not to send that child to school until the September following their fifth birthday, may request that they are admitted out of their normal age group – to reception rather than year 1.

Governors will make decisions on the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views; information about the child's academic, social and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group, and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. They will also take into account the views of the school's head teacher. When informing a parent of the decision which year group the child should be admitted to, the governors will set out clearly the reasons for their decision.

Where the governors agree to a parent's request for their child to be admitted out of their normal age group and, as a consequence of that decision, the child will be admitted to the age group to which pupils are normally admitted to the school the local authority will process the application as part of the main admissions round, (unless the parental request is made too late for this to be possible) and on the basis of the determined admission arrangements, including the application of oversubscription criteria where applicable. Parents have a statutory right to appeal against the refusal of a place at a school for which they have applied. This right does not apply if they are offered a place at the school but it is not in their preferred age group

Fair access protocols

The school participates in the local authority's Fair Access Protocol to allocate places to vulnerable and other children in accordance with the School Admission Code 2014. Admitting pupils under the protocol may require the school to admit above the planned admission number for the relevant year group.

Late Applications

Any late applications will be considered by the Governors' Admissions Committee, in the event of there being any available places using the above criteria. If all places have been filled, parents will be offered the opportunity of placing their child's name on the waiting list. This does not prevent parents from exercising their right to appeal against the decision not to offer a place.

Note:

In the context school admissions Catholic children are defined as children who are baptised or received into the Catholic Church, children baptised or received into the Eastern Churches in union with Rome and children of members of the Ordinariate.

ADMISSIONS POLICY - APPENDIX

Admission of children outside their normal age group.

The following is a proposed change to our Policy:

In line with 2014 Admissions Code children are expected to enter St. Bartholomew's Catholic Primary School in the September of the year in which their 5th birthday falls.

Although this is the view of the admissions authority it is important that any parent or carer seeking a variation or exception to this expectation will make their views known to the Headteacher and ask what additional support in differentiation can be applied to make admission possible.

Any decision by the Governing Body (limited circumstances) would be taken after considering the education advice carefully.

Parents do not have a right of appeal if they have been offered a place and it is not in the year group they would like. However, they may make a complaint about an admission authority's decision not to admit their child outside the normal age group through the school or authority's complaints procedure.

Schools are funded for the number of pupils they have on roll, regardless of their age.

Kent's scheme details the process for handling out of year applications:

- Parents should make an application for their child's normal age group at the usual time, in
 case their request is not agreed. At the same time, parents should approach the admission
 authority of each school to request the right to apply outside of the normal age group. The
 decision of one admission authority is not binding on another, but where one Community or
 Voluntary Controlled school is in agreement, KCC would expect all other named
 Community or Voluntary Controlled schools to agree unless they had strong reasons not to.
- Admissions authorities should ensure that parents receive a response to their request in writing before national offer day.
- If their request is agreed, their application for the normal age group should be withdrawn.
- Parents should then make a new application as part of the main admissions round the following year. Parents must apply using a paper application sent directly to the LA and include a copy of the agreement from each named school.

Parents or Carers who wish to defer entry of their child

Parents or Carers may wish to defer the entry of their child to the school.

They can defer their child's start date until later in the school year, but not beyond the beginning of the term after they turn five and not beyond the beginning of the final term of the school year in April. Children may also start part time until later in the school year, but not beyond the beginning of the term after they turn five.

If parents or carers choose to do this they will need to apply to the school during normal admissions round for entry in September. If you are offered a place in this school and accept it, the school will have to hold that place for them until the child is attending but they are not classed as being on roll so the school will not get the funding for your child until the following academic year.

If your child is born between 1^{st} April -31^{st} August, you can also defer entry but you would apply as an in-year applicant for a Year 1 place the following year. The school would not hold a place open for them for the whole of reception year. Parents or Carers would apply using the in-year process. If there are no spaces available, parents and carers can join the waiting list and appeal to the school's Admission Authority.

If your child's date of birth is before 1st April, they are compulsory school age the term after their 5th birthday. Therefore, you will apply in the normal round for a reception place (applications can be made between November and 15th January). The school will then hold this place open for them until they start in either January or April (depending on their DOB).

If a parent or carer wishes to delay entry to the school they will need to request a meeting with the Head in advance. This meeting will need to be minuted and the school will respond to the parent or carer in writing of the school's decision. It is the parents' or carers' right to defer entry to school, however, it is the decision of the Headteacher as to what year group the child should be educated in once they reach compulsory school age. During the meeting with the head you will be advised of the possible implications of having a child educated out of year group, for example: transfer to secondary school – secondary schools are under no obligation to accept a child out of year group so the child may need to go straight into Year 8 rather than Year 7 or apply to a school further away than you intended.
