## CQC Self Assessment

In previous bulletins, we told you about the new CQC assurance process for local authorities which is going to look at how Kent County Council meets the following four themes: working with people, providing support, ensuring safety and leadership. This assurance process will start from April 2023.



CQC won't just be looking at how we are performing as a council, but also how we are working with our providers, partners and people who draw on support. You may be asked for your views and evidence to support the assurance process. We are

well underway with our preparations for CQC's arrival and have been gathering evidence to show how we are performing against the four themes.

## Community Based Wellbeing Services

Community Based Wellbeing Services deliver preventative activities and services for Kent residents which help prevent or delay deterioration in an individual's health and wellbeing, thereby managing demand for statutory services. Wellbeing services by their nature connect people to their local communities, which reduces social isolation and loneliness. Services are outcome focused and person-centred, aiming to achieve the aspirations, goals and priorities as defined by the individual accessing the service though a wide range of support services and activities.

Universal wellbeing services (designed to support peopled aged over 55, or under 55 with complex needs) as well as specialist wellbeing services for adults with sensory needs, physical disabilities and dementia are running across the county. In West Kent and in North Kent (Dartford, Gravesham and Swanley) the universal wellbeing service is called Actively Involved; the latest newsletters for each of these areas provide the most up to date information on the activities and support available for people in these areas being delivered under this service.

## Influenza Outbreak in Care Homes

Following the recent communications sent to ALL Care Homes from the UK Health Security Agency (UKHSA) regarding winter readiness in South East England, Kent and Medway ICB would like to remind you of the advice given and to inform you of the process for Kent and Medway for an influenza outbreak within a care home. Please do not contact a GP in the event of an outbreak, UKHSA will inform you of the actions needed.

In the following situations:

- two or more residents or staff are unwell with flu-like illness and have tested negative for COVID-19 on LFD or PCR, or
- you are informed of a case of confirmed flu in a resident (for example if they are tested because of a hospital admission). Whilst you may not have an outbreak, UKHSA can talk you through general control measures and what you need to do if there are further cases, or
- you have an outbreak of diarrhoea or vomiting.
