2. Introduction

Barton Manor School is opening to Y7 students in September 2022. Barton Manor School will be an 11 – 18 years, coeducational non-selective school and will be part of Barton Court Academy Trust (BCAT). The Directors/Trustees of the Multi-Academy Trust act as the Admission Authority for Barton Manor School.

In order to meet the needs of the local area and to comply with the School Admission Code, the Admission Authority are required to consider, consult for at least 6 weeks on any changes or every seven years if no changes have occurred, and determine the 2022/23 academic year admission arrangements by 28 February 2021.

The Admission Authority will consider any comments made within the consultation period and determine the Arrangements for Academic Year 2022/23 and Academic Year 2023/24 at the Directors meeting in January 2021. The arrangements will then be published on our website and with the Local Authority.

This document details how we will be considering the arrangements for the academic years 2022/23 and 2023/24, with due regard to the Admission Code, Equality Act, the structure of the School and changes to national examination delivery.

Consultation will take place between Friday 20 November 2020 and Friday 8 January 2021. This document will be available on the School and Local Authority websites from Friday 20 November 2020, parents will be notified by letter and email. We will also consult by letter direct with the Local Authority and by email to those admission authorities, within the relevant statutory consultation area as defined by the Local Authority. We will also request all relevant schools to circulate the document to their parents/carers and send notification to all Nursery Schools in our area. A paper copy will be available on request.

Introductory statement

Barton Manor School, Barton Court Academy Trust's Free School, is due to open in September 2022 to Year 7 students only. Barton Manor School will be a 5-form, 11-18, non-selective school that will grow in size over time. The Sixth Form will open to students at a later date and the admission arrangements for this will follow consultation and publication nearer the time. As Barton Manor School will be located close to Barton Court Grammar School, an outstanding selective school, both schools will be able to work closely together to provide an outstanding standard of education for all students, harnessing the academic track record of Barton Court Grammar with the state-of-the-art facilities and innovative curriculum provided by Barton Manor School.

Barton Manor School will be a centre of excellence for applied studies with specialist facilities and in partnership with Barton Court Grammar School, together they will provide a rich and successful joint post-16 provision in the longer term. This will create a unique opportunity for the local area with a new free school built on a strong foundation of success coupled with brand new modern facilities to complement high standards and achievement.

Admission number(s)

The School has an admission number of 150 for entry in Year 7.

The School will accordingly admit this number of pupils if there are sufficient applications. Where fewer applicants than the published admission number(s) for the relevant year group are received, the Academy Trust will offer places at the school to all those who have applied.

Application process

The School will process applications outside the normal local authority process for co-ordinating school offers. This means you will need to complete your LA Common Application Form for your other choices of school in addition to a separate application for this school.

The closing date for applications is 31/10/2021

Offers will be made on 01/03/2022. If we have not entered into a Funding Agreement with the Secretary of State opening the School by that date, they will be conditional offers and will be confirmed once we have a signed Funding Agreement.

Oversubscription criteria

When the School is oversubscribed, after the admission of pupils with an Education, Health and Care plan naming the School, priority for admission will be given to those children who meet the criteria set out below, in priority order:

- 1. Looked after children and children who were previously looked after but immediately after being looked after became subject to adoption, a child arrangements order, or special guardianship order.¹
- 2. Priority will next be given to the siblings of pupils attending the School at the time the application is received or who are attending Barton Court Grammar School.
- 3. Priority will next be given to the children of staff who have been recruited to fill a skill-shortage area.
- 4. Priority will next be given to children based on their exceptional medical or social needs. Each application must include evidence, from a medical specialist or social worker of the child's need and why they must attend this school rather than any other, based on those needs. If evidence is not submitted to the School with the application, a child's medical or social needs cannot be considered.
- 5. Priority will next be given to children living nearest to the School. We use the distance between the child's permanent home address and the School, measured in a straight line using the National Land and Property Gazetteer (NLPG) address point. Distances are measured from a point defined as within the child's home to a point defined as within the School as specified by NLPG. The same address point on the School site is used for everybody. When we apply the distance criterion for the School, these straight line measurements are used to determine how close each applicant's address is to the School.

Tie-break

If in categories 2-5 above a tie-break is necessary to determine which child is admitted, random allocation undertaken by the local authority independent of the free school will be used as a tie-break to decide who will be admitted.

Random allocation will not be applied to multiple birth siblings (twins and triplets etc.) from the same family tied for the final place. We will admit them all and exceed our PAN.

Late applications

All applications received by the School after the deadline will be considered to be late applications. Late applications will be considered after those received on time. If, following consideration of all applicants the School is oversubscribed, parents/carers may request that their child is placed on the School's waiting list.

Admission of children outside their normal age group

Parents may request that their child is admitted outside their normal age group. To do so parents should include a request with their application, specifying why admission out of normal year group is being requested.

When such a request is made, the Academy Trust will make all decisions on the basis of the circumstances of each request with the best interests of the child considered, taking into account parents'/carers' views; information about the child's academic, social and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their

Oversubscription criteria

When the School is oversubscribed, after the admission of pupils with an Education, Health and Care plan naming the School, priority for admission will be given to those children who meet the criteria set out below, in priority order:

- 1. Looked after children and children who were previously looked after but immediately after being looked after became subject to adoption, a child arrangements order, or special guardianship order.¹
- 2. Priority will next be given to the siblings of pupils attending the School at the time the application is received or who are attending Barton Court Grammar School.
- 3. Priority will next be given to the children of staff who have been recruited to fill a skill-shortage area.
- 4. Priority will next be given to children based on their exceptional medical or social needs. Each application must include evidence, from a medical specialist or social worker of the child's need and why they must attend this school rather than any other, based on those needs. If evidence is not submitted to the School with the application, a child's medical or social needs cannot be considered.
- 5. Priority will next be given to children living nearest to the School. We use the distance between the child's permanent home address and the School, measured in a straight line using the National Land and Property Gazetteer (NLPG) address point. Distances are measured from a point defined as within the child's home to a point defined as within the School as specified by NLPG. The same address point on the School site is used for everybody. When we apply the distance criterion for the School, these straight line measurements are used to determine how close each applicant's address is to the School.

Tie-break

If in categories 2-5 above a tie-break is necessary to determine which child is admitted, random allocation undertaken by the local authority independent of the free school will be used as a tie-break to decide who will be admitted.

Random allocation will not be applied to multiple birth siblings (twins and triplets etc.) from the same family tied for the final place. We will admit them all and exceed our PAN.

Late applications

All applications received by the Local Authority after the deadline will be considered to be late applications. Late applications will be considered after those received on time. If, following consideration of all applicants the School is oversubscribed, parents/carers may request that their child is placed on the School's waiting list.

Admission of children outside their normal age group
