Warm Homes is delivered by a network of registered Green Deal Advisers and Installers that have been procured to deliver measures in local authority properties. Warm Homes can signpost private residents to this network of providers who are able to access national funding streams for insulation and heating for eligible households. Annex 1: HHCRO / Affordable Warmth Eligibility

To be eligible for the HHCRO/Affordable Warmth funding residents must be in a private property (owned or rented) and must be in receipt of certain benefits. The eligibility criteria are outlined below:

You receive one of the following benefits

- Pension Credit
- Income-based job seeker's allowance
- Income-related employment and support allowance
- Income support

Or

You receive Tax / Universal Credit Recipient and not exceed the maximum income threshold

- Social residents are not eligible for HHCRO/ ECO Affordable warmth.
- This is not a reactive boiler maintenance scheme due to the time it takes to gain approval for ECO works from Ofgem.
