#### **Part 1: INITIAL SCREENING**

#### Context

Thanet District Council's proposed revisions to the draft Local Plan (preferred options) January 2017 includes a total of 17,140 new homes over the Plan period to 2031 with approximately 857 dwellings per annum. During the period 2011 to 2016 there were 1,555 new homes built in Thanet.

Secondary pupil numbers in the Thanet district are forecast to grow over the coming years as the increased primary aged population transfers to the secondary phase. The Commissioning Plan identified a need for an additional 6FE Secondary school. We are therefore seeking a promoter for this new school.

### **Aims and Objectives**

The project is to provide a new 900 place secondary school for pupils age 11 to 16. The school will include a 15 place Specialist Resourced Provision, to be operated by the appointed Sponsor, for pupils whose primary barrier to learning is Social and Emotional needs, including some pupils who will have a medical diagnosis of Autism.

## **Potential Impact**

We have carefully considered any impact that the new school may have on other Secondary Schools in Thanet district. The new school will have a phased opening during the first 3 year period and because of the predicted pressure on Secondary school places, it is not expected to have an adverse impact on other schools. The structure will be continually reviewed as we move towards opening and post-opening to ensure there are sufficient places available. It is proposed that the new school will open as follows in September 2020. However there may be a possibility to open in alternative accommodation in September 2019 as a temporary arrangement subject to discussion, and this option is also included in the table below:
