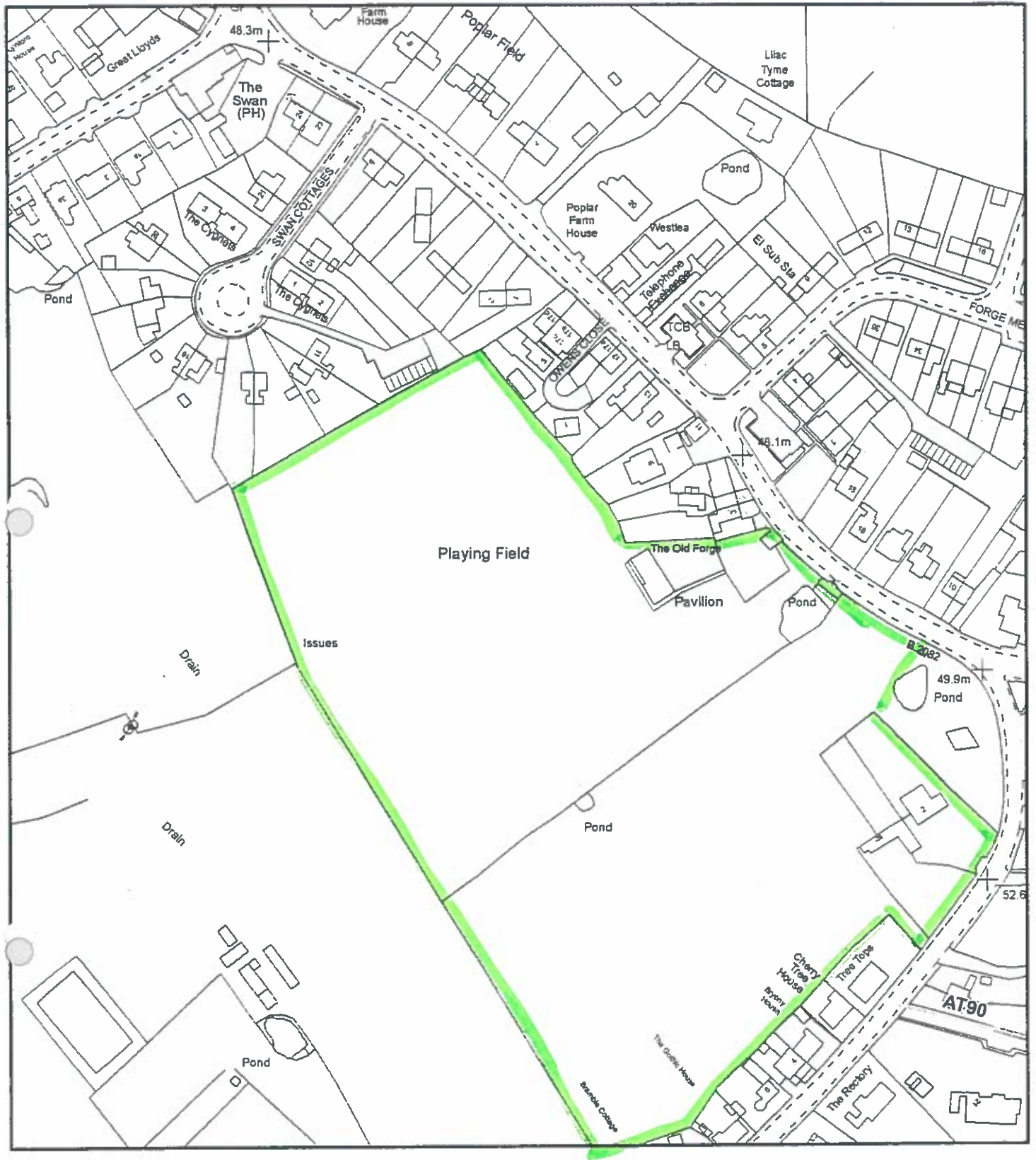

Deposit application plan**

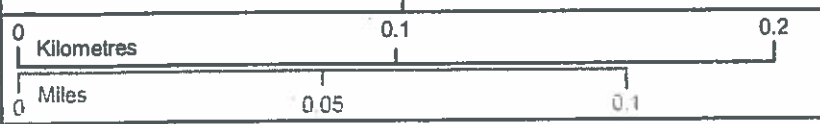
