Consultation

Introduction

The Kemnal Academies Trust (the "Admission Authority") is the admission authority for Pluckley Church of England Primary School (the "Academy"). The Admission Authority is consulting on the Academy's proposed Admission Arrangements for 2025-2026 in accordance with paragraph 1.45 of the School Admissions Code (September 2021).

Duration of the Consultation

The consultation process is open from 04/10/2023 to 15/11/2023. If you wish to comment on the proposal you must submit your response in writing during this period. Details of how to submit your views are set out below (see "How to respond to the Consultation").

Who is involved in the Consultation?

- parents of children between the ages of 2 and 18;
- other persons in the area who in the opinion of the Admission Authority have an interest in the proposal;
- all other primary and secondary admission authorities in the local area; and
- the local authority.

The Proposal

There are no material changes proposed to the policy, this consultation is being undertaken to comply with The Admissions Code's requirement to consult every seven years. However O/S criteria 4 has been simplified and clarification to the wording around In-Year Admissions and Waiting Lists has been made. Please note that the Academy admissions arrangements may look different as they have been updated to a new Admission Authority template, and there has been some rewording to use consistent wording across the Trust or to comply with requirements of the Admissions Code, which does not affect the content of the policy.

What happens next?

Following the consultation period, the Admission Authority will consider any comments received and determine how to proceed.

The Admission Authority will determine the final Admission Arrangements for the Academy by 28th February 2024. A copy of the Admission Arrangements will be published on the Academy's website by 15th March 2024.

Any subsequent objections to the published Admission Arrangements will need to be made to the Office of the Schools Adjudicator by 15th May 2024.

ADMISSIONS POLICY SEPTEMBER 2025 ENTRY

Arrangements for applications for places in Reception at Pluckley Church of England Primary School will be made in accordance with Kent's coordinated admission arrangements; parents resident in Kent can apply online here;; parents resident in other areas must apply through their home local authority. Pluckley Church of England Primary School will use Kent's timetable published online for these applications and Kent will make the offers of places as required by the School Admissions Code.

Published Admission Number (PAN)

Pluckley Church of England Primary School admits 15 pupils into Reception. If there are fewer applicants than places available all applicants will be admitted. Children are admitted to Reception in the school year in which they have their fifth birthday.

Special Educational Needs

Any child with an Education, Health and Care Plan that names the school will be admitted. As a result of this, the PAN will be reduced accordingly.

Oversubscription Criteria

If there are more applications than places available we will apply the oversubscription criteria listed below:

- 1. Looked after children and previously looked after children. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989) at the time of making an application to the school. Previously looked after children are children who were looked after, but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order). Previously looked after children also includes those who have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 2. Children or their parents who have an exceptional medical or social need which makes the school particularly suitable for the child. Priority will be given to those children or families who have a demonstrable and significant need to attend Pluckley Church of England Primary School. Applications for priority in this criterion will need to be supported by written evidence from a medical specialist or social worker who can demonstrate a special connection between the applicant's or their parent's needs and Pluckley Church of England Primary School.
- 3. Children of current staff: a) where the member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made; and/or b) the member of staff is recruited to fill a vacant post at the school for which there is a demonstrable skill shortage. This applies to all staff.
- 4. A child with a sibling on roll at the time of application. Sibling means a natural brother or sister, a half brother or sister, a legally adopted brother or sister, a step brother or sister or other child living in the same household as part of the same family who, in any of these cases, will be living at the same address at the date of their application for a place.
- Distance. We use the distance between the child's permanent home address and the school, measured in a straight-line using the National Land and Property Gazeteer (NLPG). Priority will be given to children living closest to the school.

Where a child lives normally during the school week with more than one parent at different addresses, the address where the child lives is determined using a joint declaration from the parents stating the

pattern of residence. If a child's residence is split equally between both parents, then parents will be asked to determine which residential address should be used for the purpose of admission to school. If no joint declaration is received where the residence is split equally by the closing date for applications, the home address will be taken as the address where the child is registered with the doctor. If the residence is not split equally between both parents, then the address used will be the address where the child spends the majority of the school week.

Tie-break

If in categories 2-5 above a tie-break is necessary to determine which child is admitted, random allocation undertaken by the local authority (or another body unconnected with the Academy Trust) will be used as a tie-break to decide who will be admitted.

Multiple Births

In the case of twins or other multiple births, where there is only one place available in the school, both or all of them will be considered together as one application. The school will be allowed to go above its admission number for this purpose.

Fraudulent or Misleading Applications

As an admission authority we have the right to investigate any concerns we may have about your application and to withdraw the offer of a place if we consider there is evidence that you have made a fraudulent claim or provided misleading information, for example a false address was given which denied a place to a child with a stronger claim. We reserve the right to check any address and other information provided so we can apply the oversubscription criteria accurately and fairly.

Fair Access Protocol

Local Authorities are required to have Fair Access Protocols in order to make sure that unplaced, vulnerable children are offered a place at a suitable school as quickly as possible. The school will comply with Kent's Fair Access Protocol. This may mean admitting children above the PAN.

Deferred entry for Reception places

In accordance with the requirements of the Admissions Code, if your child has been offered a place: -

- a) your child is entitled to a full-time place in the September following their fourth birthday;
- b) you can defer the date your child is admitted to the school until later in the school year but not beyond the
 point at which your child reaches compulsory school age and not beyond the beginning of the final term
 of the school year for which it was made; and
- c) if you wish, your child may attend part-time until later in the school year but not beyond the point at which your child reaches compulsory school age.

Admission of children outside their normal age group

Parents may request that their child is admitted outside their normal age group. To do so, they should include a written request with their application, setting out the year group in which they wish their child to be allocated a

place and the reasons for their request. It is important for parents to note that they will have responsibility for providing evidence to support their request. When such a request is made, Pluckley Church of England Primary School will make a decision on the basis of the circumstances of the case, based on their professional judgement of what is in the best interest of the child, taking account of the evidence and rationale provided by the parents and the views of the headteacher.

In-year admissions

For all information regarding In-Year Admissions, including details on how parents can apply for a school place, an application form to complete, the timescale in which your application will be processed and details on the right to appeal, please visit the school website.

Waiting List

Any child refused a place at the school will automatically be put on the waiting list unless a higher preference school has been offered. A waiting list will be maintained until the end of the academic year. If a parent wishes to remain on the waiting list thereafter they should contact the school. The waiting list is maintained in the order of the oversubscription criteria. This means that names can move down the list if, e.g. someone moves into the area and is higher placed under the oversubscription criteria.

Appeals

The parents of any child refused a place at the school have a right to appeal to an independent appeal panel. The decision of the independent appeal panel is binding on all parties.
