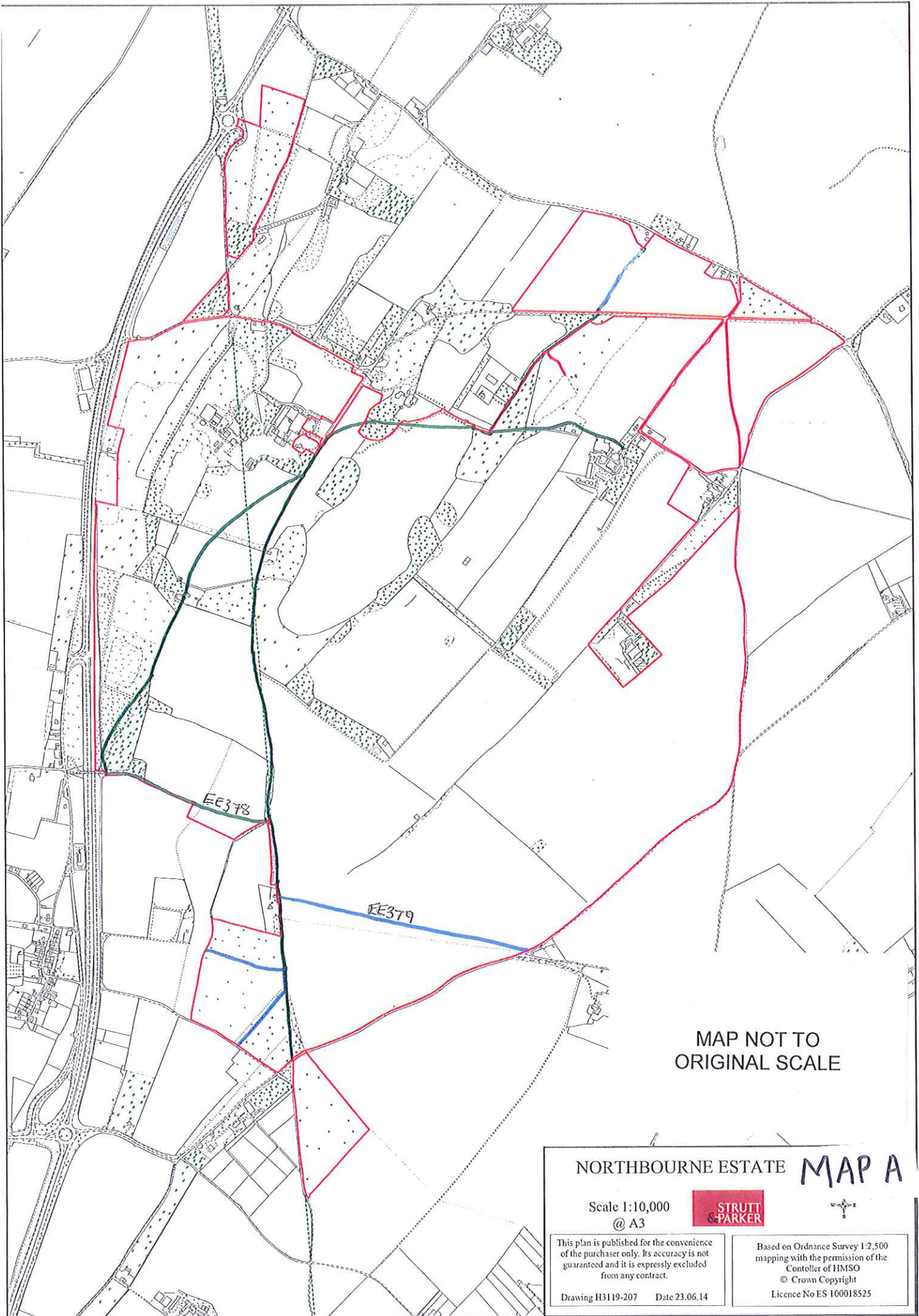

NORTHBOURNE ESTATE **MAP A**

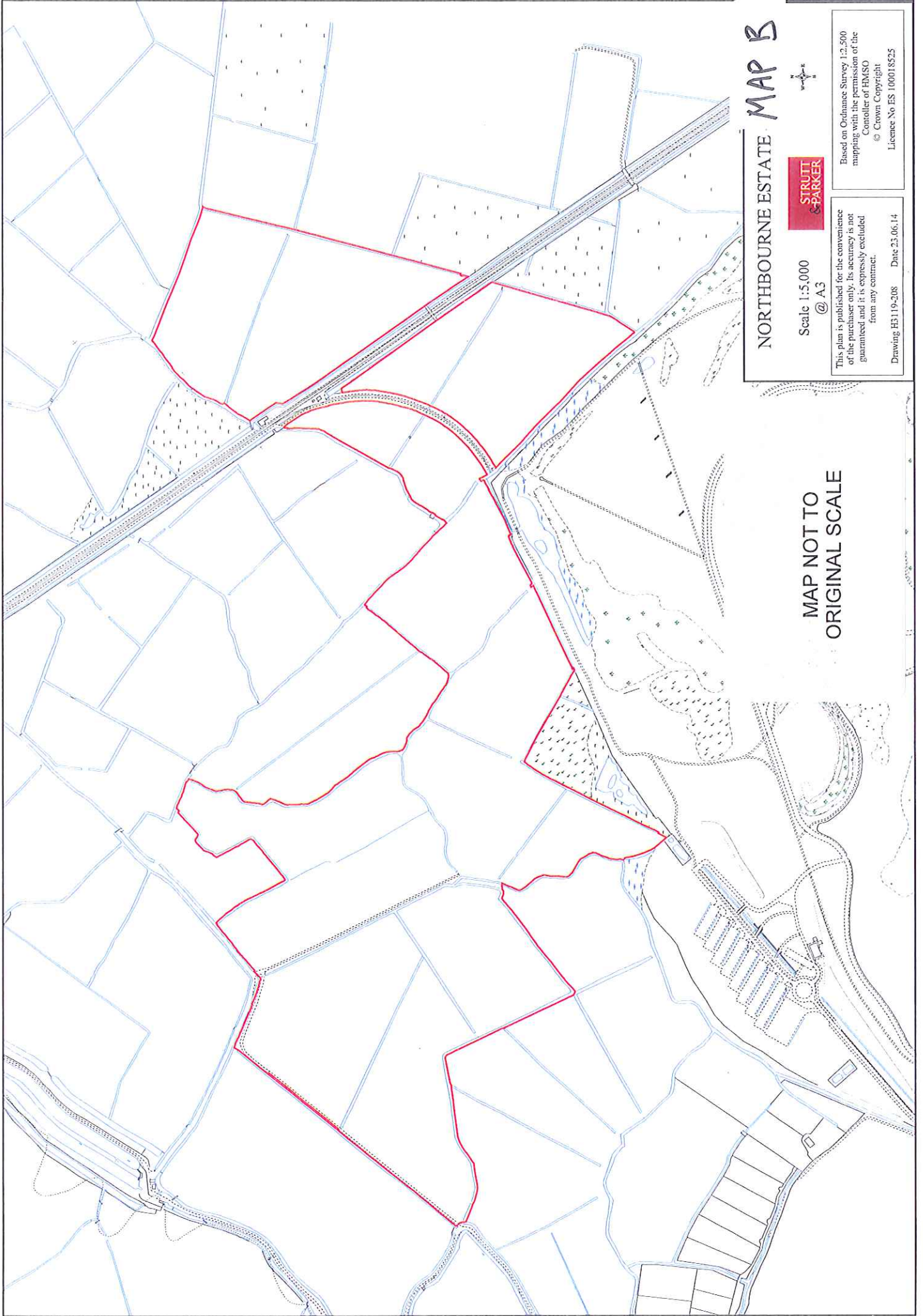
