# To apply for a Kent 16+TC for the period 1 September 2018 – 31 August 2019, every applicant must fulfil the following requirements:

- \* Be 16-19 years old and in academic years 12-14 (to be eligible your date of birth must be between 01/09/1999 and 31/08/2002)
- \* A resident of Kent (i.e. paying Council Tax to a Kent district council for KCC services)
- \* In full time education and attending a participating education or work-based learning provider

The Council reserves the right to withdraw Kent 16+ Travel Cards due to misuse or fraud. If your circumstances change and you are no longer eligible to hold a Kent 16+ Travel Card you will be required to return it.

# How to apply?

Applications and payment for the Kent 16+ Travel Card are now made direct to Kent County Council.

The easiest and quickest way to apply is through the website at www.kent.gov.uk/post16travel. You will need all of the necessary information for the student (name, address, date of birth, establishment etc) plus a passport sized photograph and your credit or debit card.

If you are unable to apply on-line then complete this form, attaching a passport photograph and cheque or postal order (made payable to 'Kent County Council') to the required value and send it to Kent 16+ Travel Card, Kent County Council, PO Box 441, Aylesford, ME6 9HJ.

Kent County Council will check with your establishment that you are attending that school or college and are therefore eligible for the scheme. Once we have all of the necessary detail, payment and have completed all necessary checks then we shall process the application and send a pass to the school or college for collection.

## Cost?

The standard full-year cost of a pass is £400. This cost can be split by applying for your first and half year passes separately. Each costs £200.

Some learning providers will offer support with finding the cost of the pass according to the following guidance:

A learner with a travel need and whose household income is above £20,818 per annum will typically receive no support and meet the cost in full.

A learner with a travel need and whose household income is between £16,190 and £20,817 per annum can benefit from a contribution to the cost payable by, and at the discretion of, their learning provider or employer, so that their K16+TC costs between £200 and £400 for a full year.

A learner with a travel need and whose household income is less than £16,190 per annum (equivalent to KCC's Free School Meals criteria) can benefit from a contribution to the cost payable by, and at the discretion of, their learning provider or employer, so that their K16+TC costs no more than £200 for a full year.

An employed 16 - 19 year old apprentice who can demonstrate hardship caused by travel-to-learn and travel-to-work pressures, can benefit from a contribution to the cost payable by, and at the discretion of, their employer, so that their K16+TC costs between £200 and £400 for a full year.

Learners who have received the full Vulnerable Learner Bursary Payment will pay £400 for a full year.

Refunds can be arranged and will be calculated based on the number of terms remaining. Refunds will be subject to a £10 administrative fee.

### Lost, stolen or damaged passes

Where the card has been lost, stolen or damaged, a replacement will be issued subject to the current replacement fee. Should the replacement be lost, stolen or damaged, two further replacements during the academic year (at a cost of £10 each) may be obtained before a further application to join the scheme will be required.

### **Terms and Conditions**
