### Whitehill Primary School Admission Arrangements Consultation for Admission Year 2025-26

The above-mentioned school is a school in the DECUS Trust.

As our own admissions authority, we are required under the School Admissions Code 2021 to review our admissions policies annually and to consult on our arrangements from time to time.

The School Admissions Code states the consultation should happen in the following circumstances:

- When changes are proposed to admission arrangements, all admission authorities must consult on their admission arrangements (including any supplementary information form) that will apply for admission applications the following school year.
- Where the admission arrangements have not changed from the previous year there is no requirement to consult, subject to the requirement that admission authorities must consult on their admission arrangements at least once every 7 years, even if there have been no changes during that period.

We, at Whitehill Primary School are consulting as it has been 7 years since our last consultation.

In addition, the Admissions Authority for Whitehill Primary School is consulting upon a reduction to the PAN admission arrangements for 2025/26. Whitehill Primary School is located in the Gravesham area in the borough of Kent.

# Whitehill Primary School is consulting on a proposal to decrease the Published Admission Number (PAN) for the 2025/26 academic year, from the current PAN of 90 pupils to a new PAN of 60 pupils for 2025/26.

#### The proposed reduction will not affect any child currently on roll at the school.

Whitehill Primary School is currently three form entry, however, for the last five years reception has been undersubscribed on National Offer Day. Subsequently, it is financially not viable for the school to continue to arrange the reception cohort into three classes.

Looking at historic and current admissions data for the school and considering the decline in birth rate seen across Kent and Nationally, it is not financially feasible for the school to have three reception classes moving forward as it is very unlikely that the school will fill to 90. As

such, we are seeking a reduction to PAN that will mean that the reception numbers for Whitehill Primary School will reduce from 90 to 60 for September 2025. This change will prevent the additional and building financial burdens being placed on Whitehill that are unsustainable.

We would like the views of everyone who feels that they may be affected by this proposed reduction to the Published Admission Number. We are therefore consulting with:

- parents of children between the ages of two and eighteen
- other persons in the relevant area who in the opinion of the admission authority have an interest in the proposed admissions
- all other admission authorities within the relevant area (except that primary schools need not consult secondary schools)
- whichever of the governing body and the local authority who are not the admission authority
- any adjoining neighbouring local authorities where the admission authority is the local authority

The consultation will open on October 23rd 2023 and any comments relating to the proposed changes need to be received by December 1st 2023.

The Local Governing Body will meet soon after the closure of the admissions consultation to consider any comments. If no comments are received, the policy will be considered at the next available meeting of the Local Governing Body and recommended for approval by the DECUS Trust board.

#### Admissions Arrangements for Entry to Reception in September 2025

These are the published admissions arrangements for entry into Whitehill Primary School & Nursery Reception in September 2023. In accordance with mandatory provisions of the School Admissions Code 2021, these arrangements may not be varied except in circumstances identified in paragraph 3.6 of the Code.

#### Admission:

The Planned Admission Number (PAN) for 2025 is 60.

Before the application of the over-subscription criteria, children with a Statement of Special Educational Need (SSEN) or a Health and Care Plan (EHCP) that name the school will be admitted. As a result the published admission number will be reduced accordingly.

Where the number of children seeking admission exceeds the number of places available, the following criteria will be applied in the order in which they are set out.

#### **Deferred entry for Reception places**

Parents offered a place in Reception for their child have a right to defer the date their child takes up the place, or to take the place up part-time, until the child reaches compulsory school age. Children reach compulsory school age on 31 August, 31 December or 31 March – whichever of those three dates follows (or falls on) the child's 5th birthday. Places cannot be deferred beyond the beginning of the summer term (April) of the school year for which the offer was made.

#### Admission of children outside their normal age group

Parents may request that their child is admitted outside their normal age group. To do so, they should include a written request with their application, setting out the year group in which they wish their child to be allocated a place and the reasons for their request. When such a request is made, the Head will make a decision on the basis of the circumstances of the case, based on their professional judgement of what is in the best interest of the child, taking account of the evidence and rationale provided by the parents.

#### **Over-Subscription:**

#### 1. Looked After Children and previously Looked After Children:

A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989) at the time of making an application to a school.

A previously looked after child means such children who were adopted (or subject to child arrangements orders or special guardianship orders) immediately following having been looked after and those children who appear to the admission authority to have been in state care outside of England and ceased to be in state care as a result of being adopted.

A child is regarded as having been in state care outside of England if they were in the care of or were accommodated by a public authority, a religious organisation, or any other provider of care whose sole or main purpose is to benefit society.

- 2. Medical health, social and special access reasons will be applied in accordance with the School's legal obligations, in particular those under the Equality Act 2010. Priority will be given to those eligible children whose mental or physical impairment means they have a demonstrable and significant need to attend a particular school. Equally this priority will apply to children whose parents'/guardians' mental or physical health or social needs mean they have a demonstrable and significant need to attend a particular school. Such claims will need to be supported by written evidence from a suitably qualified medical or other practitioner who can demonstrate a special connection between these needs and the particular school.
- 3. Children who have a sibling who will be attending the School when the applicant joins. In this context, sibling

refers to children who live as brother or sister in the same house, including natural brothers or sisters, adopted siblings, stepbrothers or sisters and foster brothers and sisters.

- 4. Children who have a parent who is a member of staff provided that they have been employed for a minimum of two years and/or are recruited to fill a vacant post for which there is a demonstrable skills shortage.
- 5. Nearness of children's homes to school we use the distance between the child's permanent home address and the school, measured in a straight line using the National Land and Property Gazetteer (NLPG) address point data. Distances are measured from a point defined as within the child's home to a point defined as within the school as specified by NLPG. The same address point on the school site is used for everybody.

In the unlikely event that two or more children in all other ways have equal eligibility for the last available place at the School, the names will be issued a number and drawn randomly to decide which child should be given the place. Children who do not secure a place may, on request, be added to the School's waiting list which will be ranked in line with the published oversubscription criteria.

#### **Appeals Process**

All applicants refused a place have a right of appeal to an independent panel constituted and operated in accordance with the School Admission Appeals Code.

Whitehill Primary will then instruct the Independent Appeals Panel to act on the schools behalf and they will then contact the appellant.
