#### Covid related deaths in care homes


We are aware that the CQC recently published data on the number of people living in care homes who have passed away from Covid-19 since the start of the pandemic. As CQC says, we know that death notifications alone are not a reliable indicator of quality or safety in individual care homes.

There are many other factors to consider when understanding quality in a care home setting and our commissioning team work closely with you to understand fully these aspects for every care home in Kent. We understand that the death of anyone in our care is always very saddening and we know and truly appreciate all of the work that care home staff have done in exceptional times.

#### All care home workers to be vaccinated

Please note that the government has now released the following timeline for the Covid-19 vaccination programme including the deadlines for receiving the vaccine before regulations come into force.

The 16-week grace period starts on 22 July and the last date for care home workers to get their first dose in time for regulations on 11 November, is **Thursday 16 September 2021.**

# Research on Annual Health Checks for people with learning disabilities

# Data Security and Protection Toolkit - free local support for Social Care Providers

Kent County Council (KCC) in partnership with Kent Integrated Care Alliance (KICA) has been awarded funding by the National Better Security, Better Care

programme. The funding is to support social care providers in Kent and Medway to complete the nationally recognised Data Security and Protection Toolkit (DSPT).





CARE ALLIANCE

Completing the DSPT will enable you to:

- gain access and retain use of digital tools such as, NHSmail and Proxy ordering for medicines
- evidence and demonstrate good practice by meeting data and security standards
- demonstrate compliance with data protection legislation and CQC's expectations on confidentiality and security
- help you to reassure the people you support, their families and your staff that they can trust you with their data
- evaluate and improve your data and cyber security, reducing the risk of cybercrime and data breaches

We know that you are under enormous pressure as you continue to deal with the Covid-19 pandemic. We don't want to add any extra burden so we are offering this free support to ensure that the information you store and share with health colleagues is secure.

We will be running regular workshops for adult social care providers in Kent and Medway to help your organisation prepare for registering on, and completing, the DSPT. No technical knowledge is needed. Sessions include:

- An introductory webinar to the Data Security and Protection Toolkit
- How to register workshop
- Sessions covering each of the 4 topic areas of the toolkit (Staffing & Roles, Policies & Procedures, Data Security, IT Systems & Devices)
- 1:1 support and peer support will also be available.
