Important: all data in this publication is derived from three main sources as follows: -

- Kent County Council is the primary source for tonnage information and residual waste destinations.
- Waste Data Flow in terms of summary information on data input by the 13 councils.
- Waste management companies in relation to countries of end destinations.

The Kent Resource Partnership staff are entirely reliant on these sources and do not, and can not, produce original data themselves.

NOTE 1

This publication provides information on the total municipal waste in the Kent CC authority area. This includes waste (both recycled and non-recycled) that is not classified as household waste; either because it was collected as part of a commercial waste operation or because the material is not currently considered as household waste (even though it derived from a household) e.g. plasterboard, soil, rubble etc. Therefore Kent's household waste sent for reuse, recycling or composting (Ex NI192) of 46.3% (as validated by Defra's latest statistics), is calculated using a subset of the total tonnage data provided within this publication.

NOTE 2

For this financial year, some dry-recycling tonnage from the 13 Kent councils was processed through Materials Recycling Facilities (MRFs) or with companies who may send their feedstocks abroad (e.g. wood for biomass). The KRP thanks Countrystyle Recycling Ltd and Viridor Waste Kent Ltd for the provision of information to us about the countries of end destination of their outputs. The KRP is very grateful for the co-operation shown.

NOTE 3

On the basis of industry experience for tonnages via charities, we have allocated tonnages 'abroad'. This includes items (e.g. clothes) that are collected by UK based charities and re-used by people in other countries.

NOTE 4

Waste Data Flow publishes information for 'Kent County Council' even though this is an amalgamation of all 13 Kent councils' information. Thus, the information for Kent Resource Partnership on pages 6 to 15 also incorporates all tonnages for Kent County Council.

Note 5

Every effort has been made to ensure the figures in this publication are correct. However, as the figures are based heavily on information from the national Waste Data Flow system, factors that impact on calculations are very likely to be replicated in this publication. Additionally, if the publication includes an inadvertent error, we would be pleased to be advised. On behalf of the Kent Resource Partnership (KRP), we are pleased to share findings from our latest Materials End Destinations Publication covering 2016/17. In addition to this, and to provide some context, pages 40 to 52 show the partnership's performance over the last five years from 2012/13 to 2016/17.

The total municipal waste collected by the 13 Kent councils was just over 731,000 tonnes. We are delighted to report an impressive 79.0% of this total was treated within the County; 14.1% across other parts of the UK and as little as 6.9% was sent abroad for onward treatment. When comparing performance to the last five years, we are proud to demonstrate a high level of consistency in managing our resources within Kent and the UK. This in turn, has continued to keep transport and environmental costs low for our residents.


With the continued commitment and support from our residents, we are also pleased to share the news that we have managed to achieve our highest recycling rate to date, recorded at 46.3%. This represents an improvement of just over 2.2 percentage points compared to the previous year. Alongside this, the 13 Kent councils continue to divert as much of their waste resource away from landfill as possible. 2016/17 sees another 'partnership best' which records only 2.8% of Kent's materials going to landfill – this represents an impressive reduction of just over 3.7 percentage points, compared to the previous year.







Resource Destinations




