

You must complete and submit to us information in accordance with the following checklists in order that we can efficiently and effectively deal with your application:

- 1 Information Checklist
- 2 Detailed Design Checklist
- 3 Pre-Adoption Checklist

We will carry out and complete the assessment and communicate with you in accordance with our customer service standards at all times.

Early consultation with us will provide an opportunity to resolve any potential problems and avoid delays, before proposals are submitted for approval.

We would encourage you, wherever possible, to design schemes that are in accordance with Kent Design.

All information must be provided in both electronic and paper formats as required. Digital information of site details in autocad format must be provided and be based on National Ordnance Survey co-ordinates for importing to our G.I.S software. All information must be sent to the appropriate Divisional Manager.
