## Low Carbon Across the South East (LoCASE)

Grants of up to £10,000 are available to support small and medium-sized enterprises (SMEs) in the South East to tackle and adapt to climate change through saving energy and making their business more competitive.

- Any business can qualify to use this money towards having energy efficiency measures installed for their business, with both the cost of materials and installation being covered
- For a business that offers low carbon or "green" goods or services, a business development grant is also available, which can be used against a wide variety of costs such as marketing, consultancy, equipment, IT software, product/ process development, accreditation and certification

Grant funding will form 40% of the cost of an eligible project, with the remaining 60% matched by the applicant business.

## **Weston Anniversary Fund**

Grants of between £30,000 and £150,000 are available to registered charities, places of worship and state schools for capital projects that benefit local communities in the UK. The funding is for capital projects that will make a significant difference to local communities in the UK. Eligible projects include:

- New community facilities
- Improvement of community facilities
- New fixed playground equipment, climbing walls or multiuse games area in a public playing field
- Purchase of large or expensive items if it is crucial to supporting local people e.g. minibus for elderly day care, equipment for a training room, community café fit out
- Purchase of land or property with a minimum of a 25 year lease with a clear community benefit

Total project costs must be at least £30,000 and not exceed £300,000. Grants must be spent and projects completed by 31 December 2020.

## **Big Lottery Fund - Reaching Communities**

The Big Lottery Fund has paused its Reaching Communities Fund as it develops the application process, trains new staff, and embeds new ways of working into the Fund. Big Lottery hopes that the changes made to the Fund will make it easier for groups and communities to apply for funding, and will increase its ability to make the best funding decisions.

Currently, voluntary or community groups in England can apply for grants of between £10,000 and £500,000 to cover the costs of projects that make positive changes within their own community. The Reaching Communities Fund will reopen 2nd April 2018 with new conditions.

### Government Unlocking £330 Million From Dormant Accounts to Build a Fairer Society

Up to £330 million from dormant bank and building society accounts will be used to help the homeless, disadvantaged young people, local charities and other good causes in the UK over the next four years. Around £280 million will be allocated to initiatives across England to help disadvantaged young people into work, provide housing for families and vulnerable people, and tackle problem debt. Of this:

£135 million will be used by Big Society

- Capital (BSC) to fund stable and long-term accommodation for vulnerable groups as well as to provide support for local charities and social enterprises
- £90 million will also be invested in support of projects that help disadvantaged young people into employment
- £55 million is set to be awarded to financial inclusion and capability initiatives which will tackle issues such as problem debt

Innovate UK is an executive non-departmental public body, sponsored by the Department for Business, Energy & Industrial Strategy. It aims to drive productivity and growth by supporting businesses to realise the potential of new technologies, develop ideas and make them a commercial success.

Grants of up to £35,000 are available to charities, social enterprises, community groups, statefunded schools and colleges for projects in disadvantaged communities that help people start a new business or increase financial capability.

As a general guide, RBS fund projects that offer training, support, qualifications, work placements, employment, self-employment, career guidance and enterprise opportunities. For example (and this is not an exhaustive list), projects in the past have targeted women with low literacy and numeracy and no work experience, the homeless, unemployed people, disadvantaged young people, women in rural areas, students about to leave school, ex-offenders and those with a history of addiction.

### **South East Business Boost (SEBB)**

Grants of up £10,000 are available to businesses in **Kent & Medway** to help boost companies and increase employment. The aim of the scheme is to improve business resilience, profitability and competitiveness. The programme will provide 'growth grants' to local businesses, creating new jobs and 'new to the firm' products. It will also support 'pre-start' companies and 'start-up' companies. Grant funding may be used to cover the following:

- Business Development: funding required enabling expansion of the business (for example, new technology and related processes)
- Plant, Machinery & Equipment: costs of and installation of machinery and hardware, and training required to operate it
- Intangible Items: including costs of purchasing new IT software and training

## **KCC - Combined Members Grants**

Kent County Councillors (also known as Members) have grants available to support a wide range of community initiatives, including:

- Local events and activities
- Purchase or repair of equipment and furniture
- Promotional materials and website creation/redesign
- Mentoring support to assist local groups to become more sustainable
- Sports projects
- Community safety schemes
- Small-scale pilot projects

Grants are available to properly-constituted organisations – such as voluntary and community groups, societies and charities, social enterprises and parish/town councils – for projects that benefit local communities. Members may jointly support a project where it benefits more than one area/community.

## Biffa Awards - Recreation and Community Buildings

Grants of between £10,000 and £75,000 are available to improve community spaces and places for outdoor recreation (green spaces, woodland walks, play areas, sports facilities). The project must be located within 5 miles of a significant Biffa operation or within 10 miles of an active Biffa Landfill site. You can check this using the Postcode Checker on the Biffa Awards website. The project's site must also be within 10 miles of any licensed landfill site (visit the Environment Agency website). The total cost of

the project should be less than £200,000 and there must be a minimum of 104 days of full public access to the project per year.

### **SUEZ Communities Trust**

Grants of up to £50,000 are available to not-for-profit organisations for improvements to local community facilities, historic buildings and structures, sport and recreation facilities. Projects must be located within three miles of a qualifying SUEZ UK waste treatment site and within three miles of a licensed landfill site (this can be any landfill site, not just those owned by SUEZ UK) - use the Suez Postcode Checker to confirm this. All projects must have unrestricted public access for a minimum of 104 days.

## The Childcare Business Grants Scheme

Grants are available to encourage more good quality, affordable and reliable childcare to give working families more childcare provision choices. This scheme will also help entrepreneurs to start up and run their own businesses in England. The Scheme is open to newly-registered early years childminders, childcare providers on domestic premises and Childminder Agencies (CMAs) in England. There are three types of grants available:

- A £500 grant for an early years childminder or childcare provider on domestic premises
- A £1,000 grant for an early years childminder or childcare provider on domestic premises of children with special educational needs and disability (SEN/D)
- A £1,000 grant for a Childminder Agency (CMA)

All costs incurred for the set-up of a business will be considered as eligible. This includes: courses attended, health checks, DBS checks, public liability insurance, house or commercial building insurance cover, additional car insurance to cover the transportation of the children in care, and any additional equipment that is purchased.

## **Kent Community Foundation - Funding for Individuals**

Kent Community Foundation has four distinct funding streams that offer direct support to disadvantaged young people, including young carers, children with disabilities or with a long-term illness:

- Ivy and Jane Charitable Fund Young Carers up to the age of 18 who look after someone who has a disability, illness, mental health condition, or a drug or alcohol problem. Grants of up to £1,000 are available for purchasing particular items of need such as school uniform, books or laptops. The fund will also consider activities that the young carer might otherwise miss out on, thereby helping them to have enjoyable childhood experiences.
- Ward and Partners Charitable Fund children with physical disabilities, long term illnesses and/or life limiting conditions. Grants of up to £2,000 are available for requests for respite, equipment, short breaks and 'make a wish' holidays for terminally ill children.
- Rooney Foundation Fund children with physical disabilities, long term illnesses and/or life limiting conditions. Grants of up to £3,000 towards requests for respite, equipment, short breaks and 'make a wish' holidays for terminally ill children
- Kent Young People's Fund children and young people in Kent and Medway who are disadvantaged, vulnerable, marginalised or at risk in some way. Grants of up to £500 for activities and opportunities that the young person otherwise would not be able to afford and from which they would therefore be excluded. For example; school trips, extracurricular activities or purchase of an item, such as a laptop.
