Kent facts and figures

The food and drink production industry is one of the UK's largest manufacturing sectors.

This report looks at the number of food and drink production enterprises in Kent. It also looks at the number of jobs in food and drink production and the contribution of agriculture to the industry.

Summary

- Kent has 2,180 food and drink production enterprises as of 2024 accounting for 3.4% of all enterprises in the county.
- Four Kent districts have a higher proportion of food and drink production enterprises than the national average of 4.1%.
- Farming enterprises (crop and animal production) account for 86.5% of food and drink production enterprises in Kent.
- As of 2023 there were an estimated 16,000 jobs in the food and drink production industry, just under two thirds of which were in crop and animal production.
- As of 2021 Kent had 2,534 agricultural holdings employing 13,253 farm workers.

Introduction

The food and drink production industry is defined as all businesses involved in processing raw food materials, packaging, and distributing them. This includes fresh, prepared foods as well as packaged foods, and alcoholic and non-alcoholic beverages.

This report looks at food and drink production industries in Kent. Data on the food and drink production industry is based on Standard Industry Classification (SIC) codes. This is the main classification system used for EU industrial statistics.

This report looks at the number of food and drink production enterprises, employee jobs, the number of agricultural holdings and the agricultural labour force.





Enterprises

The number of food and drink production enterprises comes from information from the UK Business Counts dataset produced by the Office for National Statistics (ONS). The UK Business Counts dataset is an extract compiled from the Inter Departmental Business Register (IDBR) which contains information on VAT traders and PAYE employers. The UK Business Counts dataset records the number of enterprises that were live at a reference date in March each year giving a snapshot of businesses that were live at that time. It is broken down by size band, industry, and turnover. Further information is available from the Office for National Statistics about the methodology used for producing these data.

Employee jobs

The number of employee jobs in the food and drink production sector comes from information from the Business Register and Employment Survey (BRES) produced by the ONS. The BRES is a sample survey which collects employment information from businesses across the whole of the Great Britain economy for each site that they operate. The survey covers all businesses in Great Britain registered for VAT and/or PAYE. BRES does not cover the very small businesses neither registered for VAT nor PAYE, neither does it include self-employed workers unless they are registered for VAT or PAYE.

The data provides us with an estimate of employee jobs and total employment (number of employees plus the number of working owners).

BRES is a sample survey and produces estimated employment figures. These estimates are of a good quality at higher levels of geography, for example region, however the quality of the estimates deteriorates as the geographies get smaller. This should be remembered when considering the quality of county and district estimates.

The survey provides us with estimates of employees by industrial sector. The food and drink production sector used in this bulletin is defined using the 2007 Standard Industrial Classification (2007SIC). Detailed information is published by the Office for National Statistics about the types of industry which make up each of the industrial sectors is available from the UK Standard Industrial Classification of Economic Activities.





Agricultural holdings and labour force

Finally, this report looks at estimates of agricultural holdings and labour force using information from the annual survey of agriculture and horticulture produced by the Department for Environment, Food & Rural Affairs (DEFRA). The survey takes place in June each year in England, Scotland, Wales, and Northern Ireland. While the survey takes place each June, the sample changes each year. In years such as 2013, 2016 and 2021 the sample size was increased. This enables DEFRA to produce good quality estimates for detailed geographies in those years. In other years the sample size is smaller to reduce the burden on farmers and detailed agriculture and horticulture statistics are not produced in those years.

Food & Drink Production Enterprises in Kent

The UK Business Counts dataset records the number of enterprises that were live as of March each year, giving a snapshot of businesses that were operating at this point in time. It is broken down by size band, industry, and turnover.

All numbers are rounded at source. Values may be rounded down to zero, so all zeros are not necessarily true zeros. Totals across tables may differ by minor amounts due to the rounding methods used. Percentages are rounded to one decimal place.

4.1% of enterprises nationally are concerned with food and drink production. The South West has the highest concentration of food and drink production enterprises accounting for 9.6% of all businesses. London has the lowest concentration (0.5%), and the South East has the second lowest (2.8%).

Over recent years the number of food and drink production enterprises has fallen in all regions of England except London.

Table 1 overleaf shows the number and proportion of food and drink production enterprises in English regions. It shows the number and percentage change since the previous year as well as five-year change.


Chart 1 shows the proportion of food and drink production enterprises in local authorities in England. While no Kent district is within the top 20% of districts with the highest concentration of food and drink production enterprises in the country (those with 7.6% or more) four districts are above the national average (Ashford, Folkestone & Hythe, Dover and Tunbridge Wells). Dartford is in the lowest 20% in the country (those with 0.7% or less).

Table 19 in the annex at the end of this bulletin lists the number and proportion of food and drink production enterprises in all 296 local authorities in England, in order of the local authority with the highest proportion of food and drink production enterprises to the least.





Chart 1: Food and Drink Production enterprises in England



Map 1 shows the proportion of food and drink production enterprises in Kent and Medway MSOAs. MSOAs are a geographical hierarchy designed to improve the reporting of small area statistics in England and Wales.


The map shows that areas with the highest proportions of food and drink production enterprises tend to be in mid and east Kent. These areas are largely the more rural MSOAs. The districts in the West of the county and around urban areas, especially around the main towns such as Maidstone, Ashford and Canterbury have the lowest percentage.

3.4% of enterprises in Kent are concerned with food and drink production as of 2024. This is below the national average (4.1%) but higher than the regional average (2.8%).

The highest concentration of food and drink production enterprises in Kent can be found in Ashford (415 enterprises accounting for 6.4% of all enterprises in the district). Dartford has the lowest number and proportion in Kent (30 enterprises, 0.7%).

In the last year only Ashford and Thanet have seen a rise in the number of food and drink production enterprises, and six of the Kent districts saw no change. All Kent districts have seen a fall in the last 5 years except Dartford (+5), and Thanet has seen no change at all. As a result, Kent has had a 9.2% fall in the number of food and drink production enterprises. This is larger than the national decrease of 7.0% and the regional fall of 7.4%. The Kent district with the largest 5 year percentage change is Dover with a drop of 17.1%.


The five-year change in food and drink production enterprises can be seen in chart 2. Dartford saw an increase (+20.0%) and Medway saw a slight increase (+5.6%), both with 5 more food and drink production enterprises than five years ago.

The food and drink production sector is made up of four main subsectors: crop and animal production, fishing and aquaculture, manufacture of food products and manufacture of beverages.

Table 3 overleaf shows that crop and animal production are by far the largest part of the food and drink production industry with 1,885 enterprises accounting for 86.5% of the food and drink production enterprises in Kent. Ashford has the highest number of crop and animal production enterprises (385) accounting for 92.8% of all the food and drink production enterprises in the district.

Fishing & aquaculture enterprises make up the smallest proportion in Kent with 60, accounting for 2.8% of food and drink production enterprises in the county. Fishing and aquaculture enterprises in Kent are largely located unsurprisingly in coastal districts.

Looking in more detail at the enterprises which are classified as food and drink production industries the growing of non-perennial crops make up the largest proportion of food and drink production enterprises in Kent closely followed by animal production. Regionally and nationally, animal production makes up the largest proportion of enterprises followed by growing of non-perennial crops. This can be seen in table 4.

Medway has a lower proportion of crop and animal production enterprises but a much higher proportion of food and drink manufacturing enterprises.

Please note that all data is rounded at source so values may be rounded down to zero, however all zeros are not necessarily true zeros. This is particularly true for detailed industrial breakdowns.

The size of an enterprise can be classified as micro, small, medium, or large depending upon the number of workers it employs. The following table shows the number of employees within each size classification.





The majority of food and drink production enterprises in Kent (88.5%) are micro enterprises (employing 0-9 people). Very few food and drink production enterprises in Kent are classed as large enterprises (those employing 250 people or more) and these can only be found in Maidstone, and Swale.

The number of food and drink production enterprises by employment size band in Kent districts are shown in table 5 overleaf.

65.4% of Kent food and drink production enterprises have an annual turnover of under £200,000, this reflects a similar picture to that seen nationally (68.0%) and regionally (66.9%). This is shown in table 6 overleaf.

Employee jobs in Food and Drink Production

The Business Register and Employment Survey (BRES) provides us with estimates of the number of employee jobs by industrial sector. The food and drink production sector used in this bulletin is defined using the 2007 Standard Industrial Classification (2007SIC). All numbers are rounded. To comply with the ONS requirements, all data is rounded to the nearest 100, however percentages are calculated using unrounded data. The latest data is for 2023.

An estimated 1.8% of employee jobs in England are in food and drink production. This has grown by 2.3% (+11,000 jobs) since 2018.

The East Midlands region has the highest number and proportion of jobs in food and drink production. The South East region has the third lowest proportion (1.5%) and is below the national average.

Kent has a higher proportion of food and drink production jobs than the regional and national average. As of 2023 it was estimated that there were 16,000 employee jobs in food and drink production in Kent, accounting for 2.5% of all jobs in the county.

Swale and Maidstone have the highest number of food and drink production jobs in Kent (Swale 4,000 and Maidstone 2,500 employees) accounting for 7.5% and 3.2% of the employee jobs within each district respectively.

Swale (7.5%) and Dover (3.7%) have the highest proportion of food and drink production jobs in the county. Gravesham district has seen the biggest increase in food and drink production jobs since 2018 with 500 more jobs within the industry, an increase of 441.7%.

Canterbury (-800, -50.8%), Dartford (-200, -36.4%), Dover (-300, -15.4%), Folkestone & Hythe (-100, -14.3%) and Tunbridge Wells (-400, -25.0%) are the districts in Kent to see the number of food and drink production jobs fall over recent years.

Table 8 shows the number and proportion of food and drink production jobs in 2023 and the five-year change.

When compared to other authorities in England, Swale and Dover are within the top 20% of local authorities with the highest proportion of employee jobs in the food and drink production industry in the country (those with 3.5% or more).

Dartford is the only Kent authority to be within the bottom 20% of local authorities with the lowest proportion of jobs in the food and drink production industry (those with 0.6% or less).

Table 20 in the annex at the end of this bulletin lists the number and proportion of food and drink production employee jobs in all 296 local authorities in England, in order of the local authority with the highest proportion of food and drink production employee jobs to the least.








Chart 4: Employee jobs in food and drink production in English authorities


Map 2 shows the proportion of food and drink production employee jobs in Kent and Medway MSOAs. MSOAs are a geographical hierarchy designed to improve the reporting of small area statistics in England and Wales.

The map shows that all districts within Kent except Canterbury have areas with higher density of Food & Drink production job employees. When looking at the whole county, the densest areas are in central and south Kent.

Tables 9 and 10 show the number and proportion of jobs in those industries which make up the food and drink production sector. The majority of food and drink production jobs in Kent (62.5%) are within crop and animal production, hunting and related service activities. This is considerably higher than is seen nationally where crop and animal production account for a far smaller proportion of jobs (26.2%). This reflects the importance of the agricultural industry to food and drink production within Kent.

Kent has a much lower proportion of jobs in manufacture of food products than the national average (34.4% in Kent compared to 66.3% in England).

Agricultural Industry in Kent


This report has shown that agriculture accounts for a significant part of the food and drink production sector in both the number of enterprises and the number of people it employs.

This section looks at information from the survey of agriculture and horticulture produced by the Department for Environment, Food & Rural Affairs (DEFRA). It provides estimates of agricultural holdings and workers. The latest data is for 2021.

As of June 2021, there were an estimated 2,534 agricultural holdings in Kent.

Chart 5 shows the number of agricultural holdings in Kent and Medway local authorities in 2021 compared to other authorities in England. Table 21 in the annex at the end of this bulletin lists the number of agricultural holdings in local authorities in England in 2021. The table also includes the number of agricultural workers in English local authorities in 2021, and is ordered by the local authority with the highest number of agricultural workers to the least.

More than half the agricultural holdings in Kent (51.0%) were involved with growing of plants and vegetables (cereals, cropping and horticulture) and 40.1% with animal production.

Tables 13 and 14 show data regarding the agricultural holdings in Kent & Medway.

Ashford district has the largest number of agricultural holdings (524) covering some 42,439 hectares. Arable and cereal crops cover a large proportion of that land. It also has the highest head of cattle, sheep, and pigs.

Dartford and Gravesham have the lowest amount of farmed land. Tunbridge Wells district has the highest number of poultry having at least 9 times as many as any other local authority.

County level figures are not available from the 2021 data. However, data has been published for ITLs (International Territorial Levels). ITLs (formerly NUTs - Nomenclature of Territorial Units) are a way of subdividing the country for statistical purposes allowing comparisons with other countries. Kent (ITL2) is made up of 5 ITL3 areas: Medway; Kent Thames Gateway (comprising Dartford, Gravesham, and Swale); East Kent (comprising Canterbury, Dover, Folkestone & Hythe, and Thanet); Mid Kent (comprising Ashford and Maidstone); and West Kent (comprising Sevenoaks, Tonbridge & Malling and Tunbridge Wells).

Of the 13,253 agricultural workforce in Kent, Mid-Kent makes up the largest proportion of this with 4,226 (31.9%) workers. This also equates to the fourth largest ITL3 agricultural workforce in the South East (incl. London). Nationally, Mid-Kent has the 26th highest agricultural workforce out of 130 ITL3 areas nationally.



Swale and Maidstone are within the top 20% of local authorities in England with the highest number of agricultural workers (2,056 workers or more).


Thanet, Dartford and Gravesham are within the bottom 20% with the fewest agricultural workers (278 workers or less).

Swale district has the highest number of agricultural workers in the county with 3,148 workers. This has grown by over 25% since 2016 (+655 workers).

Maidstone and Tonbridge and Malling have also seen considerable growth with 535 and 332 more agricultural workers respectively, an increase of 26.0% and 27.9% between 2016 and 2021.

Thanet district has the fewest agricultural workers (220) and has seen very little change over recent years.

Six Kent districts now have fewer agricultural workers than in 2016. Canterbury has seen the biggest reduction with 643 fewer people employed in agriculture, a fall of 42.8% over the last five years.
