Kent Community Foundation 20th Anniversary Fund: Core Support

Three-year core funding is available for selected community groups in Kent and Medway that have previously received funding from Kent Community Foundation (KCF), to enable them to continue their work in local communities. Grants of up to £ 27,600 (over three years) are intended to be used towards existing core costs, e.g. utilities, rent, service delivery staff, support staff.

Three year tapering support is available, starting in April 2021. There will be one grant per district in Kent and Medway (13 in total) and grant is for smaller organisations with an average income of up to £300,000. Applicants must have history of successful grants with KCF – three since January 2018 with all due impact reporting submitted.

Where applicants are successful in obtaining Core Support funding, they will be ineligible for further KCF funding during Years 1 and 2 (2021/22 and 2022/23). This restriction would not apply in Year 3.

Sport England - Return to Play

Grants are available to not-for-profit community organisations for projects addressing the challenges coronavirus/COVID-19 has posed to people taking part in sport and physical activity in England. The Fund is divided into three strands.

- Small Grants – Grants up to £10,000 to help sport and activity groups, clubs and organisations respond to the immediate challenges of returning to play in a Covid-19-safe environment.
- Community Asset Fund – Grants of between £10,001 and £50,000 to help local sports clubs and organisations to adapt and open important places and spaces that can help them welcome back their local community safely
- Active Together – A total of £1.5 million for a crowdfunding initiative to help sports clubs and organisations set up their own campaigns to help sustain them through the crisis.

Dormant Assets Scheme Expansion

The scheme is led by industry and backed by the government with the aim of reuniting people with their financial assets. Where this is not possible, this money goes towards social and environmental initiatives across the UK. To date over £745 million has been released to support these initiatives.

In response to COVID-19, £150 million of dormant assets funding was announced to expand an affordable credit scheme to help people struggling with debt, and support the charity and voluntary sector across the UK as it continues to

play a vital role during the pandemic.

As a response to a consultation, the Government has proposed an expansion to the scheme, with the potential for more than £800 million to be made available to support the UK as it recovers from the coronavirus pandemic.

PRS Foundation - Open Fund for Organisations

Grants of up to £10,000 are available for any not-for-profit organisation based in the UK to support new music projects led by promoters, large performance groups, talent development organisations, venues, festivals and curators in the UK. The Foundation's funding priorities are:

Government - Financial Support for Apprenticeships - Employer Incentive

Financial support is available to help employers in England hire new apprentices in a move designed to boost employment following the coronavirus (COVID-19) outbreak. The scheme provides employers that hire a new apprentice between with a payment of:

- £2,000 for each new apprentice aged 16-24
- £1,500 for each new apprentice over the age of 25

The Government will make this payment in addition to the £1,000 payment that employers already receive for taking on an apprentice aged 16 to 18 or under the age of 25 with an education, health and care plan.

Deadline: If employers take on new apprentices between 1st February-31st March 2021, they can apply until 30 April 2021.

Government - Kickstart Scheme: New Jobs for Young People

Employers from across Great Britain can access funding to create new jobs for young people aged 16 to 24 who are claiming Universal Credit. The jobs created should give young people the opportunity to build their skills in the workplace and to gain experience to improve their chances of finding long-term work.

Employers will receive funding for 100% of the relevant National Minimum Wage for 25 hours a week, plus associated employer National Insurance contributions and employer minimum auto-enrolment pension contributions. Employers will be able to top up this wage, while the Government will also pay employers £1,500 to set up support and training for people on a Kickstart placement, as well as helping pay for uniforms

and other set up costs.

Deadline: Applications accepted at any time. The scheme will initially be open until December 2021.

Government - Kick-starting Tourism

Small grants of between £1,000 and £5,000 are available for small businesses in England's tourist destinations to help them recover from a dramatic loss of business caused by the coronavirus pandemic and the resulting lockdown. CBILS provides financial support to smaller businesses (SMEs) across the UK that are losing revenue, and seeing their cashflow disrupted, as a result of the COVID-19 outbreak.

The scheme is a part of a wider package of government support for UK businesses and employees. Access to the scheme has been opened up to those smaller businesses that would have previously met the requirements for a commercial facility but would not have been eligible for CBILS. Kent Social Enterprise Loan Fund (KSELF)

Does your charity or CIC have expansion plans, require additional working capital, or need support to fund a new project? KSELF is a blended loan and grant fund, which aims to bridge the increasing funding gap for Kent's new and existing social enterprises, by offering an unsecured facility of between £10k and £100k.

Applications are welcome from social enterprises, with:

- Clear social aims and community benefit
- Trading activities which form a significant part of income
- Assets and/or profits used and retained for the benefit of the community
- Specific power to borrow

DCMS - Youth Covid-19 Support Fund

Grants are available to community and national youth organisations in England to help mitigate the impact of lost income during the winter period due to the coronavirus (COVID-19) pandemic, and ensure services providing vital support can remain open. The purpose of the funding is to:

- Enable the struggling, but most impactful, youth organisations in England to continue operating, where they may have scaled back service provision or temporarily closed due to reductions in their income as a result of the Covid-19 pandemic
- Ensure that young people, especially those who are disadvantaged, have uninterrupted access to services
- Prevent local grassroots organisations from permanent closure

Local organisations may request funding of up to whichever is the lower of:

- 25% of their annual income; or
- Deficit from November 2020 to March 2021; or
- £250,000

National organisations may request funding of up to whichever is the lower of:

- 25% of their annual income; or
- Deficit from November 2020 to March 2021; or
- £2 million

Funding is intended to cover essential business expenditure, such as staff salaries, and fixed/operational costs.
