### Multi-Agency Safeguarding Adults Training Calendar 2020/2021 January to March 2021

#### One day workshops

- Multi-agency Safeguarding Adults Training: adult legal literacy

#### COVID-19 update

As a result of the Coronavirus COVID-19 pandemic, face to face training has not been possible, and the Board is now offering facilitated online training sessions for staff from statutory partner agencies, which enable delegates to participate through a video conferencing platform.

The multi-agency training is primarily for those staff with responsibility for direct practice in safeguarding. As safeguarding is integral to all work, it is important that delegates have the agreement and support of their line manager and that provision is made to facilitate their attendance.

The training is interactive, relevant to practice and will form part of delegates' CPD requirements.

Workshop participants will need a suitable secure and safe place to undertake the 3-hour training sessions, without distractions, including use of a computer with video conferencing facilities. Training dates can be found overleaf.

The workshops are delivered as either one 3-hour session (for half day courses), or two 3-hour sessions (for whole day courses), with built in breaks as required.

Course materials will be e-mailed in advance, along with detailed instructions for participants, including any preparation which may be required.
