Funding for COVID-19 response and recovery

Many of you will have been liaising with the Infection Control Fund Administration Team at KCC. Many thanks to all those that have correctly completed their monthly report for spend to end of March 2021. They are currently working through the next round of funding called the Infection Control and Testing Fund and need answers to their queries before they are able to issue funding to you. If you have not been able to submit your monthly report for spending to the end of March 2021, the reporting link will be reopening next week and a request will be sent out to those that need to complete it.

Landmark Domestic Abuse Bill receives royal assent

The Domestic Abuse (DA) Bill has passed both Houses of Parliament and has been signed into law this week. The Domestic Abuse Act gives new protections to millions of people who experience abuse by ensuring a range of measure including:

- wide ranging legal definition which includes emotional, coercive or controlling behaviour and economic abuse
- better access to special measures in court rooms
- placing the guidance on "Sarah's law" on a statutory footing
- recognising children who witness or experience domestic abuse as victims
- placing a legal duty on local authorities in England to provide support to victims of abuse and their children in safe accommodation.

The domestic abuse agenda is an important one for Kent County Council and the new statutory duties coming through the act are welcomed. For many years, the council has worked extensively with partner agencies to strengthen their collective response and in March 2020 the Kent and Medway Domestic Abuse Strategy was published. Work to meet this strategy is overseen by the cross-partnership Kent and Medway Domestic Abuse and Sexual Violence Executive Group which includes Kent Police, Kent Fire and Rescue and KCC. In line with the Domestic Abuse Act, the Kent and Medway Public Health Observatory will be leading on a needs assessment to inform a review of our strategy and influence future commissioning decisions.

KCC commissioners worked with partners to commission the Kent Integrated Domestic Abuse service which provides support for survivors across both community based and accommodation based support across Kent. The service includes Referral Assessment and Triage, Core Community Support and Training, and Education and Awareness. Together they're exploring how support can be strengthened and extended using the statutory guidance and new burden funding linked to the Domestic Abuse Act. Domestic Abuse reaches across our communities irrespective of age, gender, ethnicity sexuality and socio-economic background, and has lifelong consequences. In England and Wales, domestic abuse has been estimated to cost government and services around £66billion annually. This includes a cost to employers of upwards of £14million per year in lost productivity and output, not to mention the impact of non-physical forms of domestic abuse or the physical injuries a survivor may have. The workplace can be a place of safety for those experiencing abuse and it's key that businesses deliver a domestic abuse response to their employees. 
