#### How this links to the Kent Adult Carers' Strategy 2022-2027?

Our 'Kent Adult Carers' Strategy 2022 to 2027' sets out our aims for working with all our partners,

making welcomed changes towards improving the experiences of unpaid adult carers in Kent.

The plan was developed in partnership with carers, people that draw on support, carer organisations, staff, and county councillors. Carers highlighted what is important to them through three core principles and summarised the eight key moments when carers may need extra support.

Co-production workshops: Care Quality Commission themes

You might have heard about government's plans for social care reform in England. This covers a ten-year national programme which includes the intention to relaunch an assessment process of local authorities' adult social care functions by the Care Quality Commissioning (CQC) starting in April 2023. This means that Kent County Council, among other local authorities, will be assessed to see how they are meeting standards as set out by the CQC.

The standards cover four themes and are supported by 'I statements' and 'We statements' which describe what people should experience when interacting with services.

The four themes are:

- working with people
- providing support
- ensuring safety
- leadership.

#### We want to hear from you!

CQC won't just be looking at how we are performing as a council, but also how we are working with our providers, partners and people who draw on support. If you work closely with us, or receive care and support from the council, you may be asked for your views to support the assurance process.

We are currently completing a self-assessment process to identify how we are currently performing against the four themes, and **we would love to hear your views**.
