Who are we?

- We are Kent County Council. We look after public services which support people in Kent.
- Adult Social Care and Health work with you to help you look after your care and support.

This can include physical health and mental health.

Adult Social Care includes
 Occupational Therapist and Social
 Care Community teams, for care
 and needs assessments. We may
 use technology to help us
 summarise over conversations with
 you when you are referred to us.
 This will help us to keep an
 accurate record of our care and
 support to you.



Why do we use your information

- We required by law to provide health and social care services. This means we are covered by law to use your information. We do not always have to ask for your permission to use your information.
- We will only share information when we need to do so and with people who need to know. We have security in place to stop

information	being	used	in	the
wrong way.				

 We also have to make sure we follow data protection laws. This is the UK General Data Protection Regulation. This means we have to provide certain information to you. We use this privacy notice to keep you updated.



What information will we use?

- We will use your personal information. This can include your name, contact details, age, NHS number and financial information.
- We will also use special category information. This is information that is more sensitive. This can include information about your needs, wishes and circumstances, your beliefs, your race or ethnic origin and your health.
- We may collect this information from you, other organisations who look after your health or people that may know you.
- We use this information to ensure you are receiving the right care and support.
- This means we only use information for these purposes only.



Who will we share your information with?

- We will only share information to organisations who will help you to look after your health and social care.
- This can include NHS providers, District & Borough Councils and people representing you.
- We may also share information that has your personal details removed. This helps us to keep track of how well we are doing and what we can do to improve.



How long do we keep your information for?

- We can only keep information for as long as we need it.
- We have a record document that tells us how long we can keep information for. This will be different depending on the information we use.
- We check regularly to make sure we only keep information that is useful to us.

What are my rights?

- You have rights under the UK General Data Protection Regulation. They are:
- know what we are doing with your

- information and why we are doing it
- ask to see what information we hold about you
- ask us to correct any mistakes in the information we hold about you
- object to direct marketing
- make a complaint to the UK Information Commissioner
- You have the choice on if you wish for your information to be used for wider purposes. This can include purposes such as service planning.
- You can make your choice on the NHS website.
- We will let you know if there have been any breaches to your information in line with data protection legislation.



Who can I contact?

- You can contact the <u>Information</u>
 <u>Resilience and Transparency Team</u>
 to exercise your rights.
- You can contact our <u>Data</u>
 <u>Protection Officer</u> to make a complaint or raise a concern.
- You can make a complaint to the UK Information Commissioner. You can do this by phoning 0303 123 1113 or go to their website.
